
Request for Purchase: \$55,400

Background: The city's decision to purchase the above services is based on the following:

- The Public Work's Streets Department maintains all roadways inclusive of striping.
- Striping, over time, wears and requires replacement.
- The city published a competitive Invitation to Bid.
 - Three (3) bidders responded.
 - The lowest responsive, responsible bidder is Maintenance Coatings, Co.
 - Bid Range = \$55,400 – 85,200 = \$29,800 or (54%)
