Request for Proposal Amendment #3

The following changes / clarifications / additions have been added to the Invitation to Bid project specifications and plans:

1. **QUESTION:** Would you please provide the refuse and yard waste sticker volume for the past several years. Can the City tell us how many refuse stickers were sold per year over the past 5 years. What is the break down by sticker type (garbage / yard waste vs. leaf)?

ANSWER: see attached data

The information contained in the document titled, “Sticker Sales-Wheaton” attached to the Request for Proposal Amendment II, for the City of Wheaton Residential Solid Waste Collection and Disposal Service, RFP, and this Amendment III, including the attachment hereinafter (“SSW”), is strictly subject to the following disclaimer and limitations:

1. **None of the information contained in the SSW was generated, assembled or created by the City of Wheaton, its employees or agents. Until the requests set forth in Amendment II were made by an outside third party, the City possessed none of the information set forth in the SSW.**

3. **The City makes absolutely no representations, warranties or promises with regard to the accuracy or inaccuracy of the information set forth in the SSW.**
4. **No proposer or persons acting on a proposer’s behalf should rely, in any manner, on the information set forth in the SSW in formulating its proposal to the City.**
5. **No proposer is entitled to use or rely in any manner whatsoever on any of the information contained in the SSW and acknowledges that if it does, wholly or in any manner, it is proceeding solely and completely at its own risk.**
6. **By submitting its proposal, a proposer warrants and agrees that it has not relied, wholly or in any part, on information contained in the SSW and that it fully waives and releases any and all claims, actions, causes of action, demands, requests for change orders, reliance, promissory estoppel, or any other theory in law or equity or claims against the City of Wheaton in consequence of its provision of the SSW to the proposer.**

2. **QUESTION:** Can the City verify that the recycling carts are City-owned?
ANSWER: Reference Refuse & Recycling Option 1: Stickers/Subscriptions page 2 of 2 #5:
"The city already owns a fleet of Rehrig Pacific HuskyLite® Roll-out Carts that are used for Recyclables. Most are 65 gallons, and some are 35 gallons."
Comment: Ownership of the recycling carts will transfer to the City at the end of its current contract term.
3. **QUESTION:** How many residents have back door service?
ANSWER: Currently there are 2 individuals who receive this service at no cost.
4. **ADDITIONAL REQUIREMENT:** reference General Specifications page 3 of 9 #13: The following items shall be added to the requirements for Monthly Reporting :
- Number of Refuse stickers sold this month
 - Number of Yard Waste stickers sold this month
 - Number of Leaf stickers sold this month
 - Number of customers registered for 20gl refuse cart subscription service this month
 - Number of customers registered for 35gl refuse cart subscription service this month
 - Number of customers registered for 65gl refuse cart subscription service this month
 - Number of customers registered for 95gl refuse cart subscription service this month
 - Number of customers registered for 35gl Organic cart subscription service this month
 - Number of customers registered for 65gl Organic cart subscription service this month
 - Number of customers registered for 95gl Organic cart subscription service this month
 - Number of customers registered for 35gl Recycling cart subscription service this month
 - Number of customers registered for 65gl Recycling cart subscription service this month
 - Number of customers registered for 95gl Recycling cart subscription service this month
 - If RFID service is selected
 - Billing collection statistics reflected in households
 - Billing collection statistics reflected in dollar value
 - Other (to be determined)

5. **CORRECTED REQUIREMENT:** reference Special Terms and Conditions for Proposals page 3 of 6 #6: CHANGE the following timeframe as follows:

6. **EMPHASIZED REQUIREMENT:** reference Special Terms and Conditions for Proposals page 5 of 6 #4:
"Description of deviations from Contract language, referencing the pertinent section by name and number"
The city's evaluation of proposals will include contract terms/deviations.
