

ORDINANCE NO. F-1710

AN ORDINANCE ESTABLISHING THE COMPENSATION  
OF OFFICERS, ASSISTANTS AND EMPLOYEES OF THE  
CITY OF WHEATON, ILLINOIS, AND  
PROVIDING FOR A PAY PLAN FOR EMPLOYEES OF THE CITY.

BE IT ORDAINED by the City Council of the City of Wheaton, Illinois:

Section 1: That the Pay Plan for Employees of the City established by Ordinance No. F-1636, passed on April 16, 2012, remains in effect without change for 2013/2014, except for an amendment to the General Occupation Pay Schedule, Pay Grade G10A (Exhibit A), Managerial Pay Table (Exhibit B), a One-Time Payment Table (Exhibit C) and Management Analyst position be classified in the G16 range of the General Occupation Pay Schedule.

Section 2: All ordinances or parts of ordinances in conflict herewith be and are hereby repealed.

Section 3: This ordinance shall be in full force and effect May 1, 2013, as provided by law.
