WATER PUMPING STATIONS GENERATOR REPLACEMENT

Amendment #3

The following changes / clarifications / additions have been added for the above captioned project, dated April 10, 2017, as follows. All provisions of the original Drawings, Instructions, Terms and Conditions, and Specifications shall remain in force, except as specifically modified or changed herein, or by other Addenda.

1. CLARIFICATION:

The scope of the project has changed. Due to budget constraints, we are requesting bids for the Countryside Station generator replacement only. The President Street Station generator is removed from the scope of this project. A bid for the President Street Station generator will be determined at a later date.

Because of the change in scope, the bid opening date has been revised. Bids are due prior to 11:00 a.m., C.D.T., on Wednesday, May 10, 2017. The bid opening will be on May 10, 2017 at 11:00 a.m., C.D.T, in the Council Chambers, Wheaton City Hall, 303 W. Wesley Street, Wheaton, IL.

Revised Cost Proposal form, attached, must be submitted as your proposal.

2. QUESTION: Per the bid form we are to submit specific product information under "Contractors Profile and Submittal Requirements".

- a. Item 3: What product certification is required?
- b. Item 4: What product literature is required?
- c. Item 5: What product certification is required?

ANSWER:

- a. A certification from the product manufacturer stating that the installer has been trained and approved in the installation of the product to be used. Certification letter shall be dated within twelve (12) months of bid date.
- b. Manufacturer's product literature, installation recommendations, technical data sheets for each product used, including ASTM test results indicating the product conforms to and is suitable for its intended use per these specifications.
- c. Manufacturer's certification that the products to be used meet the applicable referenced standards and these specifications.

3. QUESTION: Is it the intent of the City to award each pump station separately or both stations together to one General Contractor?

ANSWER: The scope of the project has changed. See CLARIFICATION, above.

4. QUESTION: Is this being run in a 2phase operation style or everything going together in one?

ANSWER: See CLARIFICATION, above.

5. QUESTION: Concerning the rear of the Fire house location, I see between the end of sidewalk and the rear of the building where the removal and installation will take place there are several manhole covers leading me to

assume that there are several pipes below coming and going from the adjoining pump station. My question is what weight will your engineers allow to cross these pipes.

ANSWER: There are no weight restrictions. However, please note that the scope of the project has changed and the President Street Station generator is removed from the scope of this project. See CLARIFICATION, above.
