**A RESOLUTION APPROVING WHEATON PARK DISTRICT
MAINTENANCE FACILITY PLAT OF CONSOLIDATION
(1000 W. Manchester Road)**



LOT 2 AND 3 OF MEYER'S ASSESSMENT PLAT, EXCEPT THE SOUTH 10 FEET OF LOT 3, BEING A SUBDIVISION OF PART OF THE NORTHWEST QUARTER OF SECTION 17, TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEROF RECORDED JANUARY 31, 1992 AS DOCUMENT R92-018049, IN DUPAGE COUNTY, ILLINOIS.

AND

THAT PART OF LOT 1 IN GETZ'S SUBDIVISION BEING A SUBDIVISION IN THE WEST HALF OF SECTION 17, TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEROF RECORDED SEPTEMBER 10, 1930 AS DOCUMENT 302565, COMMENCING AT THE CENTER OF SECTION 17-39-10 THENCE SOUTH 88 DEGREES 46 MINUTES 52 SECONDS WEST ALONG SAID CENTERLINE A DISTANCE OF 153.78 FEET TO THE POINT OF BEGINNING; THENCE NORTH 88 DEGREES 46 MINUTES 52 SECONDS EAST A DISTANCE OF 103.58 FEET TO A POINT; THENCE NORTH 47 DEGREES 51 MINUTES 19 SECONDS EAST A DISTANCE OF 0.74 FEET TO A POINT; THENCE ALONG A CURVE WITH A RADIUS OF 50.00 FEET A CHORD BEARING OF NORTH 23 DEGREES 33 MINUTES 49 SECONDS EAST AND CHORD LENGTH OF 40.79 FEET AND AN ARC LENGTH OF 42.02 FEET; THENCE NORTH 00 DEGREES 30 MINUTES 43 SECONDS WEST A DISTANCE OF 122.65 FEET ALONG THE EASTERLY LINE OF SAID LOT 1 TO A POINT; THENCE SOUTH 36 DEGREES 14 MINUTES 57 SECONDS WEST A DISTANCE OF 201.79 FEET TO THE POINT OF BEGINNING.

THAT PART OF AURORA WAY RIGHT-OF- WAY LYING NORTHERLY OF GABLES BOULEVARD RIGHT-OF-WAY IN THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 17, TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN DUPAGE COUNTY, ILLINOIS.
