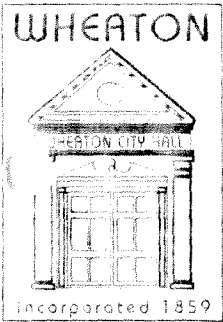

This will serve as confirmation of the understanding reached between the City of Wheaton and PAR Solutions, LLC as legislative consultants. PAR Solutions, LLC will provide the following services to the City of Wheaton:


- Consultation on the legislative and appropriations processes of the Illinois General Assembly;
- Identification of sources of state funding for municipal infrastructure projects and assistance in obtaining state grants for the projects;
- Consultation and lobbying to secure an appropriation earmarked for a flood control project for the City of Wheaton.

In consideration of such services, the City of Wheaton will retain PAR Solutions, LLC from December 1, 2006 through November 30, 2007. The fee for this service is to be paid in increments of \$3,000 the first of each month. In addition, the City of Wheaton agrees to use reasonable efforts to cooperate with PAR Solutions, LLC with regard to the achievement of their legislative goals.

This agreement may be canceled by either party upon thirty days written notice. If these terms are acceptable to you, please sign and return the enclosed copy of this document. The original is intended for your files.
