

**RESOLUTION R-49-07**

**A RESOLUTION AUTHORIZING THE ISSUANCE OF SOLID WASTE  
COLLECTION AND DISPOSAL LICENSES**

**WHEREAS**, Chapter 54 of the Wheaton City Code requires the City Council to authorize the issuance of Solid Waste Collection and Disposal Licenses; and

**WHEREAS**, the City has received Solid Waste Collection and Disposal License applications for multifamily and commercial, office, industrial or institutional collection from Waste Management of Illinois, Inc., Molenhouse Enterprises, Inc., Allied Waste Services, Veolia ES Solid Waste Midwest, LLC (formerly known as Onyx Waste Services Midwest, Inc.), Groot Industries (formerly known as Crown Recycling & Waste Services, Inc.), Flood Brothers Disposal & Recycling, and Arc Disposal & Recycling Co., Inc; and

**WHEREAS**, the City has received a Solid Waste Collection and Disposal License application for commercial, office, industrial or institutional collection from K. Hoving Recycling & Disposal, Inc.; and


**WHEREAS**, each applicant has reviewed and agreed to all requirements of the Solid Waste Collection and Disposal Licenses; and

**WHEREAS**, the City Council desires to issue Solid Waste Collection and Disposal Licenses to Waste Management of Illinois, Inc., Molenhouse Enterprises, Inc., Allied Waste Services, Veolia ES Solid Waste Midwest, LLC, Groot Industries, and Flood Brothers Disposal & Recycling to provide service to non-residential properties and multifamily residential properties that have a centralized garbage dumpster system; and to K. Hoving Recycling & Disposal, Inc. and Arc Disposal & Recycling Co., Inc to provide service to non-residential properties.

**NOW, THEREFORE, IT IS HEREBY RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois that it authorizes the issuance of a Multifamily and Commercial, Office, Industrial, or Institutional Solid Waste Collection and Disposal Licenses to Waste Management of Illinois, Inc., Molenhouse Enterprises, Inc., Allied Waste Services, Veolia ES Solid Waste Midwest, LLC, Groot Industries, Flood Brothers Disposal & Recycling and Arc Disposal & Recycling Co., Inc.; and the issuance of Commercial, Office, Industrial, or Institutional Solid Waste Collection and Disposal License to K. Hoving Recycling & Disposal, Inc. for a period ending June 30, 2008.
