PLAT OF CONSOLIDATION**





Legal Description

PART OF LOTS 20, 21, AND 22 IN BLOCK 7 OF SWIGERT'S SUNSET TERRACE, A SUBDIVISION OF PART OF THE NORTHEAST QUARTER OF SECTION 20, TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED JUNE 8, 1927 AS DOCUMENT #237203, DESCRIBED BY BEGINNING AT A POINT ON THE WEST LINE OF SAID LOT 22 THAT IS 40.0 FEET SOUTH OF THE NORTHWEST CORNER THEREOF, AND RUNNING THENCE EASTERLY 147.4 FEET TO A POINT IN THE EAST LINE OF SAID LOT 22 THAT IS 35.0 FEET SOUTH OF THE NORTHEAST CORNER THEREOF; THENCE SOUTHERLY ALONG THE EAST LINE OF SAID LOTS 22, 21, AND 20, 80.0 FEET TO A POINT THAT IS 30.0 FEET NORTH OF THE SOUTHEAST CORNER OF LOT 20, THENCE WESTERLY 148.9 FEET TO A POINT IN THE WEST LINE OF LOT 20 THAT IS 25.0 FEET NORTH OF THE SOUTHWEST CORNER THEREOF; THENCE NORTHERLY ALONG THE WEST LINE OF LOTS 20, 21, AND 22, 100.0 FEET TO THE PLACE OF BEGINNING, IN DUPAGE COUNTY, ILLINOIS.
