

**RESOLUTION R-36 -11**

**A RESOLUTION AUTHORIZING THE ISSUANCE OF SOLID WASTE  
COLLECTION AND DISPOSAL LICENSES**

**WHEREAS**, Chapter 54 of the Wheaton City Code requires the City Council to authorize the issuance of Solid Waste Collection and Disposal Licenses; and

**WHEREAS**, the City has received Solid Waste Collection and Disposal License applications for multifamily and commercial, office, industrial or institutional collection from Allied Waste Services/Republic Services, Flood Bros. Disposal Co., Groot Industries, Molenhouse Enterprises, Veolia Environmental Services and Waste Management of Illinois; and

**WHEREAS**, the City has received a Solid Waste Collection and Disposal License application for commercial, office, industrial or institutional collection from K. Hoving Recycling & Disposal; and

**WHEREAS**, the City has received a Solid Waste Collection and Disposal License application for multifamily collection from Roy Strom Company; and

**WHEREAS**, each applicant has reviewed and agreed to all requirements of the Solid Waste Collection and Disposal Licenses; and


**WHEREAS**, the City Council desires to issue Solid Waste Collection and Disposal Licenses to Allied Waste Services/Republic Services, Flood Bros. Disposal Co., Groot Industries, Molenhouse Enterprises, Veolia Environmental Services and Waste Management of Illinois to provide service to non-residential properties and multifamily residential properties that have a centralized garbage dumpster system; and to K. Hoving Recycling & Disposal to provide service to non-residential properties; and to Roy Strom Company to provide service to multifamily residential properties that have a centralized garbage dumpster system.

**NOW, THEREFORE, IT IS HEREBY RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois that it authorizes the issuance of a Multifamily and Commercial, Office, Industrial, or Institutional Solid Waste Collection and Disposal Licenses to Allied Waste Services/Republic Services, Flood Bros. Disposal Co., Groot Industries, Molenhouse Enterprises, Veolia Environmental Services and Waste Management of Illinois; and the issuance of a Commercial, Office, Industrial, or Institutional Solid Waste Collection and Disposal License to K. Hoving Recycling & Disposal; and the issuance of a Multifamily Solid Waste Collection and Disposal License to Roy Strom Company for a period ending June 30, 2012.
