
A RESOLUTION AUTHORIZING EXECUTION OF  
AN AMENDMENT TO A LOCAL AGENCY AGREEMENT WITH

FOR FEDERAL PARTICIPATION IN  
THE WESLEY STREET / MANCHESTER ROAD BRIDGE REPLACEMENT PROJECT

WHEREAS, the City of Wheaton, DuPage County, Illinois and the State of Illinois Department of Transportation have entered into a Local Agency Agreement for Federal Participation in the Wesley Street / Manchester Road Bridge Replacement Project dated October 15, 2009; and

WHEREAS, it is necessary to amend the division of cost in the original agreement to reflect changes in the level of construction engineering services for the project.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton that the Mayor is hereby authorized to execute an amendment to the Local Agency Agreement with the Illinois Department of Transportation for Federal Participation in construction and construction engineering for the Wesley Street / Manchester Road Bridge Replacement Project (Project No. BRM-7003(539), Job No. C-91-531-97).




