

RESOLUTION R-14-14

**A RESOLUTION FOR THE IMPROVEMENT BY MUNICIPALITY
UNDER THE ILLINOIS HIGHWAY CODE**

BE IT RESOLVED, by the Mayor and City Council of the City of Wheaton, Illinois that the following described streets be improved under the Illinois Highway Code: (street listing attached as Exhibit A).

BE IT FURTHER RESOLVED,


1. That the proposed improvement shall consist of Approximately 28,120 SY of pavement overlay including pavement milling, leveling binder, area reflective crack control treatment, & surface course; 26,300 SY of pavement rehabilitation including curb & gutter, drive approach & sidewalk removal & replacement, pavement milling, leveling binder, area reflective crack, control treatment, & surface course; 8,100 SY of reconstruction including pavement & base removal, aggregate & HMA base reconstruction, leveling binder, & surface course; curb & gutter drive approach & sidewalk removal & replacement; storm & sanitary structure replacement; water main replacement; water service replacement; & landscaping along various streets in the City of Wheaton; and shall be designated as Section 14-00109-00-FP.
2. That there is hereby appropriated the sum of ONE MILLION FOUR HUNDRED SEVENTY THOUSAND dollars (\$1,470,000.00) for the improvement of said section from the municipality's allotment of Motor Fuel Tax funds.
3. That the work shall be done by contract; and,

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to transmit two certified copies of this resolution to the district office of the Department of Transportation.
