WHEREAS, the City Manager has approved said request and forwarded it to the City Council for authorization.



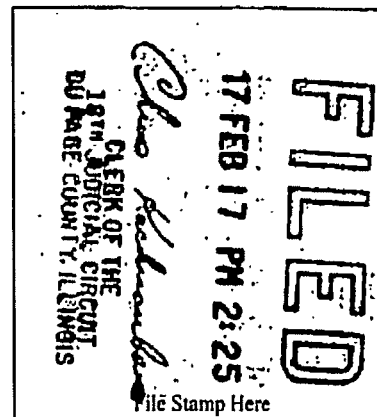
