A RESOLUTION AUTHORIZING THE EXECUTION OF AMENDMENT #1 TO AGREEMENT #C 36860 WITH DENLER, INC., FOR CONTRACTED SERVICES: CRACK SEALING AND SEAL COATING

WHEREAS, the City of Wheaton, DuPage County, Illinois and Denler, Inc., entered into an Agreement dated April 18, 2016, to provide labor, and/or materials and/or equipment to perform Contracted Services: Crack Sealing and Seal Coating (City Agreement #C 36860, hereinafter "Contract"); and

WHEREAS, the City has a continued need for contracted services: crack sealing and seal coating; and

WHEREAS, the City and Denler Inc., have elected to extend the Agreement for one (1) year in 2017, resulting in an annual cost not to exceed \$51, 000, as referenced in the Contractor's email dated April 25, 2017.


NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois that the Mayor is hereby authorized to execute and the City Clerk is hereby directed to attest to Amendment #1 between the City of Wheaton and Denler, Inc., Mokena, Illinois, for contracted services: crack sealing and seal coating.

AMENDMENT #1 OF AGREEMENT #C 36860
Agreement between the CITY of WHEATON, ILLINOIS
And DENLER, INC.,
for CONTRACTED SERVICES: CRACK SEALING AND SEAL COATING

This Amendment is entered into as of this 1st day of May 2017 by and between the CITY OF WHEATON, an Illinois municipal corporation ("City"), 303 West Wesley Street, Wheaton, IL 60187, and Denler, Inc., ("Contractor"), 19148 S. 104th Avenue, Mokena, IL 60448.

WHEREAS, the City and the Contractor entered into an Agreement dated April 18, 2016 to provide labor, and/or materials and/or equipment to perform Contracted Services: Crack Sealing and Seal Coating (hereinafter the "Work") as more fully recited in the Invitation to Bid issued March 2016, which was incorporated as Exhibit A of the initial Agreement; and

WHEREAS, the City has a continued need for this service, as referenced in the City's letter of April 3, 2017 incorporated herein as Exhibit C; and

WHEREAS, the City and the Contractor amended this Agreement to extend services for one year resulting in an annual cost not to exceed \$51,000, as referenced in the Contractor's email dated April 25, 2017 and incorporated herein as Exhibit D.

NOW, THEREFORE, in consideration of the agreements contained in this instrument and such other sufficient considerations, the parties agree as follows:

1. Contractor hereby agrees to perform the services described in the Agreement dated April 18, 2016, for the timeframe and price depicted in Exhibit C.
2. All other provisions of the Agreement, except as modified herein, are hereby ratified and reaffirmed.
