A RESOLUTION AUTHORIZING THE EXECUTION OF AMENDMENT #1 TO AGREEMENT #C 36856 WITH GLOBE CONSTRUCTION, INC., FOR 2017 SIDEWALK REPLACEMENT PROGRAM

WHEREAS, the City of Wheaton, DuPage County, Illinois and Globe Construction, Inc., entered into an Agreement dated April 18th, 2016 to provide labor, and/or materials and/or equipment to perform the 2017 Sidewalk Replacement Program (City Agreement #C 36856, herein after "Contract"); and

WHEREAS, the City has a continued need for the sidewalk replacement program; and

WHEREAS, the City and Globe Construction, Inc., have elected to extend the Agreement for one (1) year in 2017, resulting in an annual cost not to exceed \$150,000, as referenced in the Request for Renewal form and Contractor signature dated December 5, 2016.



AMENDMENT #1 OF CONTRACT #C 36856
Agreement between the CITY of WHEATON, ILLINOIS
And GLOBE CONSTRUCTION, INC.,
for 2017 SIDEWALK REPLACEMENT PROGRAM

This Amendment is entered into as of this 1st day of May 2017 by and between the CITY OF WHEATON, an Illinois municipal corporation ("City"), 303 West Wesley Street, Wheaton, IL 60187, and GLOBE CONSTRUCTION, INC., ("Contractor"), 1781 W. Armitage Court, Addison, IL 60101.

WHEREAS, the City and the Contractor entered into an Agreement dated April 18, 2016 to provide labor, and/or materials and/or equipment to perform the 2016 Sidewalk Replacement Program (hereinafter the "Work") as more fully recited in the Invitation to Bid issued by the Village of Downers Grove dated March 2016, which was incorporated as Exhibit A of the initial Agreement; and

WHEREAS, the City has a continued need for this service, as referenced in the City's letter of December 2, 2016 incorporated herein as Exhibit C; and

WHEREAS, the Contractor has agreed to hold fees as stated for the timeframe requested as referenced in the Contractor's letter dated December 5, 2016 incorporated herein as Exhibit D.

NOW, THEREFORE, in consideration of the agreements contained in this instrument and such other sufficient considerations, the parties agree as follows:


1. Contractor hereby agrees to perform the services described in the Agreement dated April 18, 2016 for the timeframe and price depicted in Exhibit D.
2. All other provisions of the Agreement, except as modified herein, are hereby ratified and reaffirmed.
