A RESOLUTION AUTHORIZING THE EXECUTION OF AMENDMENT #1 TO AGREEMENT #C 36927 WITH PRIMERA ENGINEERS, LTD., FOR DESIGN SERVICES-DOWNTOWN STREETScape PHASE I

WHEREAS, the City of Wheaton, DuPage County, Illinois and Primera Engineers, Ltd., entered into City Agreement #C 36927, herein after "Agreement" dated December 28, 2016, to provide design and construction management services for Plan Phase I, streetscape and public infrastructure improvements to Front Street between West Street and Cross Street


WHEREAS, the City has received a proposal from Primera Engineers, Ltd. for additional services outside the scope of the Agreement; and

WHEREAS, Amendment #1 to the Agreement satisfies the City's needs for additional design and construction management services for streetscape and public infrastructure improvements to Front Street between West Street and Cross Street; and

WHEREAS, the Agreement requires written approval of the additional services.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois that the Mayor is hereby authorized to execute and the City Clerk is hereby directed to attest to Amendment #1 to the Agreement between the City of Wheaton and Primera Engineers, Ltd., for Design Services-Downtown Streetscape Phase I, said amendment being attached hereto and incorporated herein as fully set forth as Exhibit 1.

AMENDMENT #1 OF AGREEMENT #C 36927

Agreement between the CITY of WHEATON, ILLINOIS
and PRIMERA ENGINEERS, LTD.,
for DESIGN SERVICES-DOWNTOWN STREETScape PHASE I

This Amendment to City Agreement #C 36927-(attached hereto and incorporated herein as fully set forth as Exhibit A), is entered into as of this 5th day of June 2017 by and between the CITY OF WHEATON, an Illinois municipal corporation ("City"), 303 West Wesley Street, Wheaton, IL 60187, and PRIMERA ENGINEERS, LTD., ("Engineer"), 650 Warrenville Road, Suite 200, Lisle, IL 60532.

WHEREAS, the City and the Engineer entered into City Agreement #C 36927 (Exhibit A) (hereinafter Agreement) on December 28, 2016 to provide design and construction management services for streetscape improvements of public infrastructure to Front Street between West Street and Cross Street for Streetscape Plan Phase I; and

WHEREAS, the City received a proposal dated May 26, 2107 (Exhibit B) from Primera Engineers, Ltd. for additional services that are outside the scope of the Agreement; and


WHEREAS, it is determined by the City that the proposal received from Primera Engineers, Ltd. for additional services, meets the City's needs for the design and construction management services for streetscape improvements of public infrastructure to Front Street between West Street and Cross Street for Streetscape Plan Phase I; and

WHEREAS, it is necessary for the City to enter into an amendment to the Agreement with Primera Engineers, Ltd., for the purpose of providing the additional services to the City.

NOW, THEREFORE, in consideration of the agreements contained in this instrument and such other sufficient considerations, the parties agree as follows:


