

**ORDINANCE NO. F-0585**

**AN ORDINANCE AMENDING THE 2000-2001 BUDGET  
CONTAINED IN ORDINANCE NO. F-0453**

WHEREAS, the City of Wheaton has heretofore adopted the Illinois Municipal Budget Law as set out in 65 ILCS 5/8-2-9.1. through 5/8-2-9.10, and

WHEREAS, the City Council of the City of Wheaton has passed an ordinance No. F-0453 adopting the annual budget of the City of Wheaton for the fiscal year commencing May 1, 2000 and

WHEREAS, said ordinance was filed with the County Clerk of DuPage County in accordance with the applicable State statutes, and

WHEREAS, the City Council desires to amend the budget contained in Ordinance No. F-0453; and

WHEREAS, sufficient funds are available to amend the budget for the fiscal year commencing May 1, 2000,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Wheaton, Illinois:

Section 1. That the budget of the Cable Television Fund be increased in the amount of \$875,000 in order to amend the following account budget:


Section 6. That all ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
