

**ORDINANCE NO. F-0734**

**AN ORDINANCE GRANTING A SIDE YARD ABUTTING A STREET VARIATION  
ON A CERTAIN PIECE OF PROPERTY COMMONLY KNOWN AS  
1103 N. WHEATON AVENUE - REXILIUS**

**WHEREAS**, written application has been made requesting a variation to Article 9.2.5<sup>1</sup> of the City of Wheaton Zoning Ordinance to reduce the required side yard abutting a street from 25.25 feet to 18.5 feet in order to construct a two-story addition onto an existing home; and

**WHEREAS**, pursuant to notice as required by the Illinois Municipal Code and the Wheaton Zoning Ordinance, a public hearing was conducted by the Wheaton Planning & Zoning Board on June 25, 2002 to consider the variation request and the Wheaton Planning & Zoning Board has recommended approval of the zoning variation.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Wheaton, DuPage County, Illinois, pursuant to its home rule powers, as follows:

Section 1: Pursuant to the Findings of Fact determined by the Wheaton Planning & Zoning Board, a variation is granted to Article 9.2.5<sup>1</sup> of the City of Wheaton Zoning Ordinance to reduce the required side yard abutting a street from 25.25 feet to 18.5 feet to allow the construction of a two-story addition onto an existing home in accordance with the plans entitled "*Rexilius Addition, 1103 N. Wheaton Avenue, Wheaton, IL; Pages 1 thru 3; prepared by H & H Design & Remodel, ON684 Gary Avenue #A, Wheaton, IL dated May 17, 2002.*"

The property that is subject of the variation is legally described as:

LOT 6 (EXCEPT ALL THAT PART THEREOF LYING NORTH OF THE SOUTH LINE OF THE NORTH 50.0 FEET OF THE SOUTH 102.0 FEET THEREOF AND EXCEPT THE EAST 58.0 FEET THEREOF) IN BLOCK 8 OF JESSE C. WHEATON JR. ADDITION TO WHEATON, BEING A SUBDIVISION OF PART OF SECTIONS 8 AND 9, TOWNSHIP 39 NORTH, RANGE 10, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED SEPTEMBER 2, 1907 AS DOCUMENT 89892, IN DUPAGE COUNTY, ILLINOIS.


The subject property is commonly known as 1103 N. Wheaton Avenue, Wheaton, IL 60187.
