

ORDINANCE NO. F-0776**AN ORDINANCE AMENDING THE 2002 TAX LEVY
CONTAINED IN ORDINANCE NO. F-0775**

WHEREAS, the City Council of the City of Wheaton passed an Ordinance No. F- 0775 levying taxes for corporate purposes for the fiscal year commencing May 1, 2002 and ending April 30, 2003, for the City of Wheaton; and

WHEREAS, said ordinance has been filed with the County Clerk of DuPage County in accordance with the applicable state statutes; and

WHEREAS, the City of Wheaton has exercised its home rule powers in adopting Ordinance No. E-1279 establishing a general corporate tax levy for the City of Wheaton in lieu of separate levies; and

WHEREAS, the City of Wheaton desires to amend Ordinance No. F-0775.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Wheaton, Illinois:

Section 1. That the County Clerk of the County of DuPage is hereby authorized and directed to amend the taxes hitherto provided for and levied in Ordinance No. F-0775 so as to reduce the amount heretofore levied.

Section 2. That the bond and interest levy of \$2,973,559 established in Ordinance No. F-0775 be abated as follows:

1. That the amount levied in Ordinance No. E-3928 of \$117,443 be abated by \$117,443 to \$0.
2. That the amount levied in Ordinance No. E-4078 of \$74,250 be abated by \$74,250 to \$0.
3. That the amount levied in Ordinance No. E-4079 of \$180,775 be abated by \$180,775 to \$0.
4. That the amount levied in Ordinance No. F-0248 of \$281,163 be abated by \$281,163 to \$0.
5. That the amount levied in Ordinance No. F-0259 of \$138,690 be abated by \$138,690 to \$0.

The resulting total levy for bond and interest shall be \$2,181,238.

Section 3. That all ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.


Section 4. That the City Clerk is hereby ordered and directed to cause a certified copy of this ordinance to be filed with the County Clerk of DuPage County.

Section 5. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, in the manner provided by law.
