

ORDINANCE NO. F-0802

AN ORDINANCE AMENDING THE WHEATON CITY CODE FEE SCHEDULE
(APPENDIX B)

BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

SECTION 1: That Section B-2 (Document sales), (2) Maps, of Article I (Administrative Fees), Appendix B (Fee Schedule) of the Wheaton City Code, 1996, as amended, is hereby further amended by revising subparagraph (d), as follows:

“(d) Address map, 42 inches by 72 inches . . . \$10.00.”

SECTION 2: That Section B-31 (Paramedic services), of Article IV (Fire Department Fees), Appendix B (Fee Schedule) of the Wheaton City Code, 1996, as amended, is hereby further amended by deleting said Section B-31 in its entirety and replacing it with the following:

“**Sec. B-31. Paramedic services.**

(1) Resident:

- (a) Response fee without transport to hospital \$50.00
- (b) Basic life support \$290.00
- (c) Advanced Life Support 1 \$330.00
- (d) Advanced Life Support 2 \$430.00
- (e) Mileage (per mile) \$5.00

(2) Non-resident:

- (a) Response fee without transport to hospital \$75.00
- (b) Basic life support \$390.00
- (c) Advanced Life Support 1 \$500
- (d) Advanced Life Support 2 \$700.00
- (e) Mileage (per mile) \$5.00

(3) Maximum fee for each mutual aid responding to Wheaton request \$500.00”

SECTION 3: That Section B-37 (Administrative fees), Article V (Police Department Fees), Appendix B (Fee Schedule) of the Wheaton City Code, 1996, as amended, is hereby further amended by deleting subparagraphs (4) and (8) in their entirety, and subsequently renumbering the existing subparagraphs.

SECTION 4: That Section B-44 (Annual animal licenses), Article VI (Business Licenses), Appendix B (Fee Schedule) of the Wheaton City Code, 1996, as amended, is hereby further amended by deleting Section B-44 in its entirety:

“Sec. B-44 (Reserved)”

SECTION 5: That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 6: That this ordinance shall become effective from and after its passage, approval and publication in the manner prescribed by law.
