

**ORDINANCE NO. F- 0998**

**AN ORDINANCE AMENDING**  
**SECTION 2A OF ORDINANCE NO. F-0949**  
(CVS Pharmacy )

WHEREAS, the Corporate Authorities of the City of Wheaton, upon further consideration, elect to amend Section 2A of Ordinance No. F-0949 only with respect to the amount of CVS Pharmacy’s contribution for a right hand turn lane improvement; and

WHEREAS, this amendment does not affect the Special Use Permit for a drug store with a drive-through pharmacy and variations in any respect from a zoning standpoint; and

WHEREAS, the Corporate Authorities of the City of Wheaton have determined that this amendment may be adopted without public hearing in consequence that it does not in any way from a zoning standpoint impact the Special Use Permit variations for the property; and

WHEREAS, CVS is willing to donate the eleven thousand six hundred thirty dollars and twenty cents (\$11,630.20) bond to the City of Wheaton in case the right hand turn lane improvement described herein is not constructed.

NOW, THEREFORE, be it Ordained by the Mayor and City Council of the City of Wheaton, DuPage County, Illinois, that sub-section 2A of Ordinance No. F-0949 is hereby repealed and rescinded in its entirety and replaced with a new sub-section 2A which shall read as follows:

- a. The Owner shall apply, and City staff shall assist the Owner in an effort to secure, any and all permits from the Illinois Department of Transportation (“IDOT”), to install and construct a right hand turn lane from northbound Blanchard Street onto eastbound Roosevelt Road as depicted on site plan A (“the Right Turn Improvements”). The Owner may commence construction of the building or other site improvements shown on site plan A (collectively the “other Site Improvements”) pending IDOT’s review of the permit application for the right hand turn lane improvements. If the Owner receives the permit for construction of the Right Hand Turn Improvements at any time prior to the issuance of an occupancy permit, it will construct the Right Hand Turn Improvements at its sole expense and upon completion and acceptance of the same from the City’s Director of Engineering, its bond shall be refunded. The Owner shall post a bond with the City in the sum of eleven thousand six hundred thirty dollars and twenty cents (\$11,630.20), which constitutes the Owners engineers estimate of the cost of said improvements. If the Right Hand Turn Improvements are not constructed during the Owner’s site improvements, the City in its discretion may proceed to construct the Right Hand Turn Improvements at any time. If the City elects not to install the Right Hand Turn Improvements, it shall retain the bond which shall be transferred to its General Fund for General Corporate Purposes. The timing of the transfer shall be in the sole discretion of the City but shall not occur prior to the Owner’s completion of its site improvements.

SECTION 4: By executing a copy of this ordinance, the Owner agrees to its terms and conditions including the provision permitting the City to retain the eleven thousand six hundred thirty dollars and twenty cents (\$11,630.20) bond for its General Fund if the Right Hand Turn Improvements are not installed.


SECTION 5: That all ordinances and parts of ordinances in conflict with or inconsistent with the provisions of this ordinance are hereby repealed to the extent of any such conflict or inconsistency.

SECTION 6: That if any part of part or portion of this ordinance shall be declared invalid by a court of competent jurisdiction, such partial invalidity shall not affect the remainder of this ordinance.

SECTION 7: That this ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as is hereby authorized and directed to be done by the Mayor and City Council.
