

ORDINANCE NO. F-1168

**AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 1, SECTION 2-1
(CITY SEAL, LOGO, POLICE AND FIRE EMBLEMS LIMITATION ON USE)
OF THE WHEATON CITY CODE)**

WHEREAS, The City of Wheaton is a Illinois Home Rule municipality; and

WHEREAS, The Corporate Authorities of the City of Wheaton have determined that it is in the best interests of the City of Wheaton to identify, describe, and limit the use of the Official Seal of the City of Wheaton, the City logo and Police and Fire Department Emblems for official City purposes;

NOW THEREFORE, be it Ordained by the Mayor and the City Council of the City of Wheaton, DuPage County, Illinois, pursuant to and in conformance with the City of Wheaton's Home Rule powers, that Section 2-1 entitled City Seal Described of Article 1 of Chapter 2 of the Wheaton City Code is hereby repealed and rescinded in its entirety and replaced with a new Section 2-1(a-d) which shall be entitled "City Seal, Logo and Police and Fire Department Emblems" which shall read as follows:

SECTION 1 Section 2-1 City Seal, Logo and Police and Fire Emblems

- a) **CITY SEAL:** The Official Seal of the City shall be a circular shape with an inscription "City of Wheaton, Illinois, in blue against a white background on the outer circle and a silhouette depicting a skyline of local buildings and trees and clouds in blue against a white background on the inner circle with the inscription "February 24, 1859" in white on the lower part of the inner circle". The City Clerk shall maintain a certified copy of the Official Seal of the City in the offices of the City Clerk for examination by the public during regular business hours.

CITY LOGO: The City logo shall be rectangular in shape and depict the North entrance to the City Hall building.

POLICE EMBLEM: The Wheaton Police Department emblem shall be a shield shape bordered by gold piping with the word "Police" in gold letters on a blue background in the upper half of the emblem, with the City Seal, (excluding trees and February 24, 1859) in the center and red and white stripes and a blue star in the lower half of the emblem.

FIRE EMBLEM: The Wheaton Fire Department emblem shall be the City Seal (excluding trees, clouds and February 24, 1859) flanked by four red and white symmetrically shaped wings with red piping and white interiors containing

the words Fire, Dept., and depictions of a fire hydrant, ladder and pike pole.

b) IMPROPER USE: The City Seal, Logo, Police and Fire Emblems shall be used only for the official business of the City of Wheaton. The City Seal, Logo, Police or Fire Emblems shall not be used in any manner except for the business of the City of Wheaton and any use without the express consent of the Corporate Authorities of the City of Wheaton, or in conformance with Subsection (c) of this ordinance, is prohibited.

c) PROPER USE: In creating print media or other layout/design applications for official City use, City staff or personnel may use the City Seal, Logo Police or Fire Emblems, or parts thereof separately or in any appropriate combination subject to the approval of the City Manager.

d) PENALTY: Any person or entity violating Subsection (b) of this Ordinance shall be subject to a minimum mandatory fine of not less than one hundred (\$100.00) dollars per day , nor more than seven hundred and fifty (\$750.00) dollars per day for each day the City Seal or Logo is unlawfully used.

SECTION 2: All ordinances and parts of ordinances in conflict with or inconsistent with the provisions of this ordinance are hereby repealed to the extent of any such conflict or inconsistency.

SECTION 3: That if any part of part or portion of this ordinance shall be declared invalid by a court of competent jurisdiction, such partial invalidity shall not affect the remainder of this ordinance.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as is hereby authorized and directed to be done by the Mayor and City Council.




