

ORDINANCE NO. F-1389

**AN ORDINANCE AMENDING THE OFFICIAL MOTOR
VEHICLE AND TRAFFIC SCHEDULES (CHAPTER 70)
FOR THE CITY OF WHEATON, ILLINOIS
(LEASED PARKING)**

BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

SECTION 1: That the Official Motor Vehicle and Traffic Schedule X-D (Leased Parking) as referred in Section 70-413 of the Wheaton City Code 1996, as amended, is hereby deleted in its entirety and replaced with the following:

Pursuant to section 70-413, the following areas are hereby designated as facilities for leased parking and the corresponding rental rates are hereby established.


- (1) Parking Lot # 3 (north side of Liberty Drive between Cross Street and Main Street), leased parking Monday through Friday: Sixty dollars (\$60.00) per quarter.
- (2) Parking Lot # 4 (north side of Liberty Drive between Main Street and Hale Street), leased parking Monday through Friday: Sixty dollars (\$60.00) per quarter.
- (3) Parking Lot # 5 (north side of Liberty Drive between Hale Street and Wheaton Avenue), leased parking Monday through Friday: Sixty dollars (\$60.00) per quarter.
- (4) Parking Lot #6 (North side of Crescent Street west of Hill Avenue), leased parking Monday through Friday:
 - (a) Wheaton resident, Sixty dollars (\$60.00) per quarter.
 - (b) Non-Wheaton resident, Seventy-five dollars (\$75.00) per quarter.
- (5) Parking Lot # 7 (southeast corner of Williston Street and Crescent Street), leased parking Monday through Friday:
 - (a) Wheaton resident, Sixty dollars (\$60.00) per quarter.
 - (b) Non-Wheaton residents, Seventy-five dollars (\$75.00) per quarter.
- (6) Parking Lot # 8 (northwest corner of Blanchard street and Avery Avenue), leased parking Monday through Friday:
 - (a) Wheaton resident, Sixty dollars (\$60.00) per quarter.
 - (b) Non-Wheaton resident, Seventy-five dollars (\$75.00) per quarter.
- (7) Parking Lot # 9 (southwest corner of Liberty Drive and Carlton Avenue), leased parking.
 - (a) Monday through Friday: Sixty dollars (\$60.00) per quarter.


- (b) Monday through Friday: \$1.50 per day.
- (8) Parking Lot #10 (southeast corner of President Street and College Avenue), leased parking Monday through Friday, \$1.50 per day. (F-1135, 2/21/06)
- (9) Municipal Parking Garage North (at Wheaton Avenue between Wesley and Front), leased parking.
- (a) Commercial lease, Monday through Friday: Seventy-five dollars (\$75.00) per quarter.
(b) Residential lease, Monday through Sunday: One hundred fifty dollars (\$150.00) per quarter.
(c) Condominium guest lease, Monday through Sunday: Two dollars (\$2.00) per day; ten dollars (\$10.00) per week; twenty-five dollars (\$25.00) per month; free (\$0.00) for one night only.
- (10) Municipal Parking Garage South (at Willow Avenue and Cross Street), leased parking Monday through Friday, Seventy-five dollars (\$75.00) per quarter.

SECTION 2. That all ordinances or parts of ordinances in conflict with provisions of this ordinance are hereby repealed.

SECTION 3: That this ordinance shall become effective from and after its passage, approval, and publication in a manner provided by law.
