

ORDINANCE NO. F-1490

**AN ORDINANCE AUTHORIZING A WATER RATE CHANGE
FOR THE CITY OF WHEATON, DUPAGE COUNTY, ILLINOIS**

BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

Section 1. That Section 74-316 (1) and (2) (Rates for water and/or sanitary sewer service, and stormwater management) of the Wheaton City Code, 1996, as amended, is hereby further amended by deleting and replacing paragraphs (1) and (2) as follows:

- “(1) (a) Effective July 1, 2010, for each user of the combined waterworks, sewerage systems, and for stormwater management, the monthly charge shall be \$4.45 per 100 cubic feet. The minimum charge for combined water service, sanitary sewer service and stormwater management shall be \$4.45 per month.
- (b) Effective May 1, 2011, for each user of the combined waterworks and sewerage systems, and for stormwater management, the monthly charge shall be \$4.70 per 100 cubic feet. The minimum charge for combined water service, sanitary sewer service and stormwater management shall be \$4.70 per month.
- (2) (a) Effective July 1, 2010, for each user of the combined system using water service only, the monthly charge shall be \$2.40 per 100 cubic feet. The minimum charge for water service only shall be \$2.40 per month.
- (b) Effective May 1, 2011, for each user of the combined system using water service only, the monthly charge shall be \$2.65 per 100 cubic feet. The minimum charge for water service only shall be \$2.65 per month.”

Section 2. That Appendix B (Fee Schedule) of the Wheaton City Code, 1996, B-8 (2) (Public Works/Water Fees), is hereby further amended by deleting and replacing paragraph 12 in its entirety as follows:

- “12. Rates for water, sanitary sewer service and stormwater management for combined water service, sanitary sewer service and stormwater management:
- (a) Effective July 1, 2010:


Section 3. That Appendix B (Fee Schedule) of the Wheaton City Code, 1996, B-8 (2) (Public Works/Water Fees), is hereby further amended by deleting and replacing paragraph 13, subparagraphs (a) and (b) as follows:

“13. Individual rates for water service, sanitary sewer service and stormwater management (noncombined) system:

- (a) Effective July 1, 2010:
 - 1. Water service, monthly (rate) per each user per 100 cubic feet \$2.40
 - 2. Water service, minimum charge per month \$2.40
- (b) Effective May 1, 2011:
 - 1. Water service, monthly (rate) per each user per 100 cubic feet \$2.65
 - 2. Water service, minimum charge per month \$2.65”


Section 4. All ordinances or parts of ordinances in conflict with these provisions are repealed.
