

**ORDINANCE NO. F-1496**

**AN ORDINANCE AMENDING APPENDIX B (FEE SCHEDULE)  
OF THE WHEATON CITY CODE**

BE IT AND IT IS HEREBY ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

Section 1: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, Section B-5 (Special Event Fees/Extraordinary Services) is hereby amended by deleting and replacing Section B-5 in its entirety as follows:


<b>B-6 Extraordinary Services</b>
