ORDINANCE NO. F-1542

AN ORDINANCE GRANTING A SPECIAL USE PERMIT FOR AN ADDITION TO AN EXISTING CHURCH ON PROPERTY COMMONLY KNOWN AS 1748 SOUTH BLANCHARD STREET - WHEATON CHINESE ALLIANCE CHURCH

WHEREAS, written application has been made requesting a special use permit to allow the construction of a 2,497 square foot one-story addition (plus basement) to the northwest corner of the Wheaton Chinese Alliance Church at 1748 South Blanchard Street, Wheaton, IL ("subject property"); and

WHEREAS, pursuant to notice as required by the Illinois Municipal Code and the Wheaton Zoning Ordinance, a public hearing was conducted by the Wheaton Planning and Zoning Board on January 11, 2011 to consider the special use permit request; and the Planning and Zoning Board has recommended that the request be granted and approved.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Wheaton, Du Page County, Illinois, pursuant to its home rule powers, as follows:

Section 1: Pursuant to the Findings of Fact made and determined by the Planning and Zoning Board, a special use permit is granted to construct a 2,497 square foot one-story addition (plus basement) to the northwest corner of the Wheaton Chinese Alliance Church all on the following-described property:

LOT 1 (EXCEPT THE EASTERLY 40.0 FEET AS MEASURED AT RIGHT ANGLES) IN BALDWIN SEARS ASSESSMENT PLAT OF PART OF LOT 7 OF THE PLAT OF THE OSWALD SITTLER FARM, IN THE NORTHEAST QUARTER OF SECTION 28, TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN ACCORDING TO THE PLAT THEREOF RECORDED SEPTEMBER 17, 1943 AS DOCUMENT 453601 IN DUPAGE COUNTY, ILLINOIS.

The subject property is commonly known as 1748 South Blanchard Street, Wheaton, IL 60189.

Section 2: Pursuant to the Findings of Fact made and determined by the Planning and Zoning Board, a special use permit is granted in full compliance with the following plans: "Wheaton Chinese Alliance Church - Site Plan, Floor Plans and Elevations" prepared by Ronald Creswell Architecture, Wheaton, IL, Sheets 0-6, dated December 5, 2010 and "Addition to Wheaton Chinese Alliance Church - Preliminary Engineering Plans" prepared by Bono Consulting, Park Ridge, IL, Sheets C-0, C-1, C-2 and C-3, dated December 8, 2010 and in further compliance with the following conditions, restrictions, and requirements:

- 1. A new privacy fence shall be installed along the north property line;
- 2. A new dumpster enclosure shall be constructed next to the existing garage;
- 3. Both the existing and proposed A/C units shall be screened with landscaping/ fencing; and
- 4. Either the existing garage shall be painted and repaired prior to an occupancy permit being issued for the addition or the garage shall be removed.
 - Section 3: All ordinances or parts of ordinances in conflict with these provisions are repealed.

Section 4: This ordinance shall become effective from and after its passage, approval, and publication in pamphlet form in the manner prescribed by law.
