

**ORDINANCE NO. F-1573**

**AN ORDINANCE AMENDING THE OFFICIAL MOTOR VEHICLE  
AND TRAFFIC SCHEDULES (CHAPTER 70)  
FOR THE CITY OF WHEATON**

**BE IT ORDAINED** by the Mayor and City Council of the City of Wheaton, Illinois as follows:

**SECTION 1:** That the Official Motor Vehicle and Traffic Schedule XII (Traffic Control Signals) as referred in Section 70-308 of the Wheaton City Code, 1996, as amended, is hereby amended by repealing and rescinding Schedule XII in its entirety and replacing it with a new Schedule XII which shall read as follows:

In accordance with Section 70-308, the following street intersections are hereby designated for the control of traffic by the means of traffic control signals:


