

**ORDINANCE NO. F-1618**

**AN ORDINANCE AUTHORIZING A WATER RATE CHANGE  
FOR THE CITY OF WHEATON, DUPAGE COUNTY, ILLINOIS**

BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

Section 1. That Section 74-316 (1) and (2) (Rates for water and/or sanitary sewer service, and stormwater management) of the Wheaton City Code, 1996, as amended, is hereby further amended by deleting and replacing paragraphs (1) and (2) as follows:

- “(1) Combined water service, sanitary sewer service and stormwater management. For each user of the combined waterworks, sewerage systems, and for stormwater management, the monthly charge shall be \$5.50 per 100 cubic feet. The minimum charge for combined water service, sanitary sewer service and stormwater management shall be \$5.50 per month.
- (2) For each user of the combined system using water service only, the monthly charge shall be \$3.45 per 100 cubic feet. The minimum charge for water service only shall be \$3.45 per month.”

Section 2. That Appendix B (Fee Schedule) of the Wheaton City Code, 1996, B-8 (2) (Public Works/Water Fees), is hereby further amended by deleting and replacing paragraph 12 in its entirety as follows:


- “12. Rates for water service, sanitary sewer service and stormwater management for combined water service, sanitary sewer service and stormwater management:
  - (a) Monthly (rate) per each user per 100 cubic feet \$5.50
  - (b) Minimum charge per month \$5.50”

Section 3. That Appendix B (Fee Schedule) of the Wheaton City Code, 1996, B-8 (2) (Public Works/Water Fees), is hereby further amended by deleting and replacing paragraph 13, subparagraphs (a) and (b) as follows:

- “13. Individual rates for water service, sanitary sewer service and stormwater management (noncombined) system:
  - (a) Water service, monthly (rate) per each user per 100 cubic feet \$3.45
  - (b) Water service, minimum charge per month \$3.45”

Section 4. All ordinances or parts of ordinances in conflict with these provisions are repealed.


Section 5. This ordinance shall be effective from and after its passage, approval and publication in pamphlet form in the manner prescribed by law for bills issued after January 3, 2012.
