

**ORDINANCE NO. F-1626**

**AN ORDINANCE AMENDING CHAPTER 70 "TRAFFIC AND VEHICLES"  
OF THE WHEATON CITY CODE**

**BE IT ORDAINED** by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

**SECTION 1:** That Chapter 70 "Traffic and Vehicles", Article IV "Stopping, Standing and Parking", Division 1, "Generally", Section 70-354 subparagraphs (g), (h), and (i) of the Wheaton City Code, 1996, as amended, is hereby amended by repealing and rescinding said subparagraphs in their entirety and replacing them with the following new subparagraphs:

(g) On-street parking time limited. When signs are erected giving notice thereof, no person shall park a vehicle for longer than the time designated in motor vehicle and traffic schedule VIII on any day except Saturdays, Sundays and legal holidays on any of the streets described in such schedule. For the purpose of this subsection, a separate offense occurs at the expiration of each maximum parking time limit.

(h) Legal holiday exception. For purposes of this chapter, legal holidays are as follows: January 1; Presidents' Day; Memorial Day; July 4; Labor Day; Thanksgiving Day; and December 25.


(i) No person shall park a vehicle in any space within an on-street or off-street time limit parking area for more than the time limit as posted between the hours of 8:00 a.m. and 6:00 p.m., nor shall a person move a vehicle from space to space within the designated parking area in order to extend the parking time limit for their use.

**SECTION 2:** That Chapter 70 "Traffic and Vehicles", Article IV "Stopping, Standing and Parking", Division 1, "Generally", Section 70-356 subparagraph (b) of the Wheaton City Code, 1996, as amended, is hereby amended by repealing and rescinding said subparagraph in its entirety and replacing it with the following new subparagraph:


(b) Customer designated parking shall include the following street blocks: 100 block of North Main Street, East Front Street, East Wesley Street, and East Liberty Drive; 100, 200 and 300 blocks of West Front Street (except the south side in front of 312 West Front Street) and West Wesley Street (except the south side of the 200 block between the alley and Wheaton Avenue and the north side of the 300 block); 100 and 200 blocks of West Liberty Drive (except the north side of the 200 block) and North Hale Street (except north of Karlskoga Avenue); and 200 block of South Hale Street (except south of the alley).

**SECTION 3.** That all ordinances or parts of ordinances in conflict with provisions of this ordinance are hereby repealed.

**SECTION 4:** That this ordinance shall become effective from and after its passage, approval, and publication in a manner provided by law.
