Concrete Repair: Countryside Reservoir (REBID)

Solicitation Process: public solicitation

Recommended Service Provider: R&W Clark Construction

The adopted FY2016/17 Water Fund budget includes \$130,000 for reservoir concrete repairs at the Countryside Pump Station.

Budget: \$130,000
Request for Purchase: \$135,600
Budget Shortfall: \$ 5,600

The proposed price of this project is \$5,600 greater than budget. The overage will be taken from fund balance reserves.

Background: The city's decision to purchase the above contractual service is based on the following:

- The City requires a contractor to repair sections of the Countryside Reservoir which has delaminated in various locations between the top surface and wall interface.
 - In October 2015 the city hired Strand Associates to prepare design documents for said repair.
- This project was originally solicited in June. That solicitation resulted in two (2) bidders with a price disparity of \$204,184 (or 331%). The low bidder was unable to provide references similar to scope of work.
 - The high bidder for the original bid reduced his bid by \$139,000 and is now the low bidder for the rebid.
- Public Notices were:
 - Posted on Demand Star and Public Purchase. These are broadcast services targeting contractors who service government entities.
 - Posted on the city website.
 - Procurement contacted:
 - i. The Engineering Design Firm, Strand Associates, requesting a list of contractors experienced in this work. Two contractor firms were identified. Each received a Notice to Bidders.
 - ii. Eight Illinois distributors for the specified materials
 - iii. The two (2) previous bidders.
- A non-mandatory pre-bid walk-through was attended by three (3) contractors.
- Three bids were submitted.
- The lowest responsive, responsible bidder is R&W Clark Construction Inc.
 - Bid Range: \$126,800 - \$253,000 or 99%
