

**ORDINANCE NO. O-2018-11**

**AN ORDINANCE AMENDING CHAPTER 2 (ADMINISTRATION), ARTICLE V (BOARDS, COMMISSIONS AND COMMITTEES) OF THE WHEATON CITY CODE**

BE IT AND IT IS HEREBY ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

Section 1: That Chapter 2 (Administration), Article V (Boards, Commissions and Committees) of the Wheaton City Code, 2016, is hereby amended by adding a new Division 16 as follows:

**DIVISION 16. – BICYCLE ADVISORY COMMISSION**

**Sec. 2-481. – Established.**

There is hereby established a bicycle advisory commission for the city.

**Sec. 2-482. – Composition; appointment of members; term of office.**

The bicycle advisory commission shall consist of no less than seven (7) and no more than twelve (12) members appointed by the mayor with the approval of the city council for three-year terms. Commission members shall be residents of the city.

**Sec. 2-483. – Purpose.**

The purpose of the bicycle advisory commission is to:

- (a) Provide advice to the city council on matters relating to bicycling.
- (b) Recommend strategies to encourage and foster bicycling opportunities in the city.
- (c) Promote bicycle education programs in the school systems and disseminate bicycle safety information to the public at large.
- (d) Review and make recommendations regarding implementation of the Wheaton Bicycle Plan, September 2011, as amended.
- (e) Establish and maintain an information network with those agencies, individuals and organizations within the city that advocate bicycling and promote the sharing of resources among them.
- (f) Perform such further duties as may be delegated to it by the mayor and city council.

**Sec. 2-484. – Meetings; reports; regulations.**


- (a) The bicycle advisory commission shall meet not less than six (6) scheduled times per year at a date and time to be determined by the commission. The commission may further meet at such times as it may designate.
- (b) The bicycle advisory commission shall report in writing to the mayor and city council on an annual basis. The report shall cover the activities of the commission for the year immediately preceding the report and shall be presented to the council during the month of October.
- (c) The bicycle advisory commission shall adopt reasonable rules and regulations for the conduct of its business.

Section 2: That all ordinances or parts of ordinances in conflict with these provisions are repealed.

Section 3: This ordinance shall become effective from and after its passage, approval, and publication in pamphlet form in the manner prescribed by law.
