**A RESOLUTION AUTHORIZING THE EXECUTION OF EXTENSION #2 TO AGREEMENT #C36768 WITH KURTZ PARAMEDIC SERVICE, INC., for PARAMEDIC SERVICES AND AMBULANCE BILLING SERVICES**

**WHEREAS**, the City of Wheaton, DuPage County, Illinois and Kurtz Paramedic Service, Inc. entered into an Agreement dated April 14, 2015, to provide paramedic services and ambulance billing services for a three-year term commencing on May 1, 2015 through May 1, 2018;

**WHEREAS**, the City exercised the first option to extend Agreement #C36768 effective May 1, 2018 through May 1, 2019.


**WHEREAS**, the City has a continued need for paramedic services and ambulance billing services;

**WHEREAS**, it is determined by the City that the Kurtz Paramedic Service, Inc. request for contract extension to provide continued paramedic services and ambulance billing services through May 1, 2020 meets the City's needs; and

**WHEREAS**, it is necessary for the City to enter into a second extension to Agreement #C36768 with Kurtz Paramedic Service, Inc., for the purpose of providing paramedic services and ambulance billing service.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois that the Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to extension #2 to Agreement #C36768 between the City of Wheaton and Kurtz Paramedic Service, Inc. for paramedic services and ambulance billing services.
