

RESOLUTION R-2019-20

A RESOLUTION AUTHORIZING THE EXECUTION OF CONTRACT NO. 58 WITH GLOBE CONSTRUCTION, INC. FOR CONCRETE FLATWORK FOR THE ANNUAL SIDEWALK REPLACEMENT PROGRAM AND MISCELLANEOUS CONCRETE WORK FOR A TOTAL AMOUNT NOT TO EXCEED \$170,000.00

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Globe Construction, Inc., 1781 West Armitage Court, Addison, Illinois 60101, for Concrete Flatwork for the Annual Sidewalk Replacement Program and Miscellaneous Concrete Work; and

WHEREAS, the City prepared a bid package (Bid Number 19-15) that included the removal and replacement of City sidewalks as a part of the City's Annual Sidewalk Replacement Program and other miscellaneous concrete flatwork, such as curb and gutter replacements; and

WHEREAS, the City budgeted funds in the Capital Projects Fund in the amount of \$150,000.00 for the Annual Sidewalk Replacement Program and the City budgeted funds in the General Fund in the amount of \$20,000.00 for Public Works Street Division concrete repairs; and


WHEREAS, the City solicited bids in a public bidding process and bids were publicly opened and read on March 19, 2019, at 11:00AM and Globe Construction, Inc., was determined to be the lowest, responsive, responsible bidder, with a unit price bid of \$56.25/SY for removal and replacement of 6" driveway pavement, \$6.10/SY for removal and replacement of 4" sidewalk, \$6.10/SY for removal and replacement of 5-6" sidewalk, \$22.50/FOOT for 18 inch wide concrete curb & gutter removal, \$23.00/FOOT for 2 foot wide concrete curb & gutter removal, \$0.50/FOOT for reinforcement bars, and \$18.00/SF for detectable warnings; and

WHEREAS, it is necessary for the City to enter into an agreement with Globe Construction, Inc., for concrete flatwork for the Annual Sidewalk Replacement Program and Miscellaneous Concrete Work; and

WHEREAS, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for the concrete flatwork for the Annual Sidewalk Replacement Program and Miscellaneous Concrete Work.


NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois that the Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to an agreement between the City of Wheaton and Globe Construction, Inc., 1781 West Armitage Court, Addison, Illinois, 60101 for a total amount not to exceed of \$170,000.00 for Concrete Flatwork for the Annual Sidewalk Replacement Program and Miscellaneous Concrete Work.
