

RESOLUTION R-2019-36

A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 51 WITH TOTAL PARKING SOLUTIONS, INC., FOR PARKING MANAGEMENT EQUIPMENT, SOFTWARE, AND SERVICES IN THE AMOUNT OF \$113,050.00, PLUS ONGOING FEES

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Total Parking Solutions, Inc. ("TPS") located at 2721 Curtiss Street, Downers Grove, Illinois; and

WHEREAS, the City developed a project and prepared a request for proposals for a Parking Management Solution which includes four (4) pay station terminals and related terminal software, equipment warranty, maintenance service, technical support, and training; and mobile license plate recognition reader ("LPR") equipment for one police vehicle and related LPR software, equipment warranty, maintenance service, technical support, and training; and parking citation management services; and

WHEREAS, the City budgeted funds for the above stated Parking Management Solution project in the 2019 Capital Projects Fund; and

WHEREAS, the City solicited requests for proposals in a public request for proposal process and proposals were opened and read on December 6, 2018 at 11:00AM and TPS was determined to be the lowest, responsive, responsible proposer. TPS's proposal, a copy of which is attached hereto and incorporated herein as if fully set forth as **Exhibit A**, sets forth an amount of \$113,050.00 for parking management equipment, software and services, plus ongoing software licensing, payment gateway services, ticket issuance, and delinquent notice fees as set forth in **Exhibit A**; and


WHEREAS, the City has determined that it is necessary and reasonable to enter into an agreement with TPS for the parking management equipment, software and services as set forth in TPS's proposal; and

WHEREAS, both parties agree to the terms and conditions set forth in the TPS proposal and the agreement provided to TPS by the City for the City's Parking Management Solution project; a copy of the agreement and exhibits are on file in the City Clerk's office and are available for review.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Wheaton, Illinois, that the Mayor is hereby authorized to execute, and the City Clerk is hereby directed in furtherance of the City's Parking Management Solutions project to attest to an agreement between the City of Wheaton and Total Parking Solutions, Inc., Downers Grove, Illinois, in the

amount of \$113,050.00 for parking management equipment, software, and services, plus ongoing software licensing, payment gateway services, ticket issuance, and delinquent notice fees, all as set forth in the attached **Exhibit A**.
