

**RESOLUTION R-2019-46****A RESOLUTION AUTHORIZING THE EXECUTION OF CONTRACT NO. 73 WITH THOMAS ENGINEERING GROUP, LLC., FOR ENGINEERING SERVICES FOR PHASE I GARY AVENUE BETWEEN HARRISON AVENUE AND JEWELL ROAD FOR A TOTAL AMOUNT NOT TO EXCEED \$165,826.59**

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Thomas Engineering Group, LLC., 55 West 252nd Street, Suite 300, Lombard, Illinois, 60148, for Engineering Services for Phase I Gary Ave between Harrison Avenue and Jewell Road; and

**WHEREAS**, the City prepared a Request for Proposal (RFP Number 19-47) that included Engineering Services for Phase I Gary Avenue between Harrison Avenue and Jewell Road and received and reviewed two submittals; and

**WHEREAS**, it is determined by the City that the proposal received from Thomas Engineering Group, LLC., in the amount of \$165,826.59 meets the City's needs; and

**WHEREAS**, the City has a satisfactory relationship with Thomas Engineering Group, LLC., as described in the Local Government Professional Services Selection Act 50 ILCS 510/4; and


**WHEREAS**, the project is not currently funded for CY 2019, however, the engineering study will be paid out of the Capital Projects Funds account; and

**WHEREAS**, it is necessary for the City to enter into an agreement with Thomas Engineering Group, LLC., for Engineering Services for Phase I Gary Ave between Harrison Avenue and Jewell Road; and


**WHEREAS**, both parties agree to the terms and conditions set forth in the RFP and the agreement contained in the City's RFP package for Engineering Services for Phase I Gary Ave between Harrison Avenue and Jewell Road.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois that the Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to an agreement between the City of Wheaton and Thomas Engineering Group, LLC., 55 West 252nd Street, Suite 300, Lombard, Illinois, 60148 for a total amount not to exceed of \$165,826.59 for Engineering Services for Phase I Gary Ave between Harrison Avenue and Jewell Road.
