RESOLUTION R-2019-89

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 87
WITH SNOW SYSTEMS FOR SNOW AND ICE REMOVAL SERVICES FOR
CITY PARKING LOTS AND GARAGES**

WHEREAS, the corporate authorities of the City of Wheaton ("City"), DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Snow Systems, 600 N. Wolf Ct., Wheeling, Illinois 60090, for Snow and Ice Removal Services for City Parking Lots and Garages; and

WHEREAS, the City prepared a bid package (Bid Number 19-82) that included Snow and Ice Removal Services for City Parking Lots and Garages; and

WHEREAS, the City budgeted funds in multiple accounts in CY2019 for a total amount of \$304,250.00 for Snow Removal Services. The City intends to appropriate funds in the CY2020 budget for costs incurred after January 1, 2020; and

WHEREAS, the City solicited bids in a public bidding process and bids were publicly opened and read on September 9, 2019, at 11:15AM and Snow Systems was determined to be the lowest, responsive, responsible bidder; and

WHEREAS, both parties agree to the terms and conditions and pricing set forth in the bid proposal and the agreement contained in the City's bid package for Snow and Ice Removal Services for City Parking Lots and Garages.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 87 with Snow Systems, 600 N. Wolf Ct., Wheeling, Illinois 60090, for Snow and Ice Removal Services for City Parking Lots and Garages at the pricing set forth in the Snow Systems Cost Proposal, which is incorporated into City of Wheaton Agreement No.87, through April 30, 2020, with the option to extend the agreement at the same prices and terms for two (2) additional one (1) year terms; and that a copy of that certain City of Wheaton Agreement No. 87 is on file with the City Clerk's office as Exhibit A to this Resolution R-2019-89 and is hereby incorporated into this Resolution as if fully set forth herein.
