

ORDINANCE NO. O-2019-50

**AN ORDINANCE AMENDING THE OFFICIAL MOTOR VEHICLE
AND TRAFFIC SCHEDULES (CHAPTER 70)
FOR THE CITY OF WHEATON**

BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois as follows:

SECTION 1: That the Official Motor Vehicle and Traffic Schedule IX, Parking meter zones, as referred in Section 70-378, of the Wheaton City Code, 2017, as amended, is hereby amended by repealing and rescinding said Schedule IX in its entirety and replacing it to read as follows:

“Schedule IX. Parking meter zones. (Sec.70-378)

Pursuant to section 70-378, the following areas are hereby designated as on street “Parking Meter Zones”.

| (4) | Wheaton Avenue | East side from Karlskoga Avenue to Union Avenue. |
| (5) | Carlton Avenue | West side from Liberty Drive to Childs Street. |
| (6) | Crescent Street | North side from Parking Lot No. 6 to President Street, both sides
from President Street to Chase Street.” |

SECTION 2: That the Official Motor Vehicle and Traffic Schedule X-A, Metered parking areas, as referred in Section 70-382 of the Wheaton City Code, 2017, as amended, is hereby amended by repealing and rescinding said Schedule X-A in its entirety and replacing it to read as follows:

“Parking time limits. Pursuant to section 70-382 the following maximum parking time limits are hereby established for the following on-street “Parking Meter Zones.”

(a) *12-hour limit:*

- (3) Liberty Drive North side from Carlton Avenue to 450 feet east thereof and from 400 feet to 550 feet west of West Street and south side from Bridge Street to 375 feet east of Carlton Avenue and from 600 to 1000 feet east of Carlton Avenue.
- (4) Crescent Street North side from Parking Lot No. 6 to President Street and both sides from President Street to Chase Street.
- (b) *9-hour limit:*
 - (1) Hale Street Both sides from Seminary Avenue to Union Avenue.
 - (2) Wheaton Avenue East side from Karlskoga Avenue to Seminary Avenue.
- (c) *4-hour limit:*
 - (1) Liberty Drive North side from 500 feet to 800 feet west of West Street and from Carlton Avenue to Bridge Street and south side from 375 feet to 600 feet east of Carlton Avenue.
- (d) *2-hour limit:*
 - (1) Front Street Meter numbers F87, F88, F89 and F90, on the south side between Ellis Avenue and Western Avenue. Meter number F104, F105, F106 and F107 on the south side between Ellis Avenue and Gary Avenue.
- (e) *1-hour limit*
- (f) *½ hour limit"*

SECTION 3: That the Official Motor Vehicle and Traffic Schedule VIII, Parking time (non-metered) limited on certain streets and off-street lots, as referred in Section 70-354 of the Wheaton City Code, 2017, as amended, is hereby amended by repealing and rescinding paragraph I.(a)(25) of said Schedule VIII in its entirety and replacing it to read as follows:

“(25) Willow Avenue South side from Naperville Street to Washington Street, both sides from Hale Street to Wheaton Avenue, and north side from Wheaton Avenue to West Street.”

SECTION 4: That the Official Motor Vehicle and Traffic VIII, Parking time (non-metered) limited on certain streets and off-street lots, as referred in Section 70-354 of the Wheaton City Code, 2017, as amended, is hereby amended by repealing and rescinding paragraph I.(b)(4) of said Schedule VIII in its entirety and replacing it to read as follows:

"(4) Wheaton Avenue

East side from Wesley Street to Karlskoga Avenue, and east side from Willow Avenue to alley north thereof."

SECTION 5: That the Official Motor Vehicle and Traffic VIII, Parking time (non-metered) limited on certain streets and off-street lots, as referred in Section 70-354 of the Wheaton City Code, 2017, as amended, is hereby amended by adding new paragraphs I.(b)(5), I.(b)(6) and I.(b)(7) of said Schedule VIII to read as follows:

"(5) Main Street

Both sides from Illinois Street to the alley north of Willow Avenue, west side from Illinois Street to Indiana Street.

(6) Willow Avenue


Both sides from Hale Street to Main Street.

(7) College Avenue

South side from President Street to Stoddard Avenue."


SECTION 6: That all ordinances or parts of ordinances in conflict with provisions of this Ordinance are hereby repealed.
