

**RESOLUTION R-2019-105**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 99 WITH THOMAS ENGINEERING GROUP, LLC., FOR PHASE II ENGINEERING SERVICES FOR REPAIRS TO THE WHEATON AVENUE PEDESTRIAN UNDERPASS FOR A TOTAL AMOUNT NOT TO EXCEED \$98,652.80**

**WHEREAS**, the corporate authorities of the City of Wheaton ("City"), DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Thomas Engineering Group, LLC., 762 Shoreline Drive, Suite 200, Aurora, Illinois, 60504, for Phase II Engineering Services for Repairs to the Wheaton Avenue Pedestrian Underpass; and

**WHEREAS**, the City prepared a Request for Quotation package (RFQ Number 19-123) that included Phase II Engineering Services for Repairs to the Wheaton Avenue Pedestrian Underpass; and

**WHEREAS**, the City budgeted funds in the Capital Projects Fund in the amount of \$550,000.00; and


**WHEREAS**, the City conducted a Request for Quotation for an emergency inspection of the Wheaton Avenue Pedestrian Underpass in 2017 and engaged Thomas Engineering Group, LLC., to provide the requested services as its proposal met the City's needs. Thomas Engineering Group, LLC., has proposed to provide the requested services for Phase II Engineering Services for Repairs to the Wheaton Avenue Pedestrian Underpass; and

**WHEREAS**, both parties agree to the terms and conditions set forth in the RFQ and the agreement contained in the City's RFQ package for Phase II Engineering Services for Repairs to the Wheaton Avenue Pedestrian Underpass.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 99 with Thomas Engineering Group, LLC., 762 Shoreline Drive, Suite 200, Aurora, Illinois, 60504, for Phase II Engineering Services for Repairs to the Wheaton Avenue Pedestrian Underpass at the pricing set forth in Thomas Engineering Group, LLC's Cost Proposal for a total amount not to exceed \$98,652.80; and that a copy of that certain City of Wheaton Agreement No. 99 is on file with the City Clerk's office as Exhibit A to this Resolution R-2019-105 and is hereby incorporated into this Resolution as if fully set forth herein.
