

RESOLUTION R-2020-58

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 136
WITH THYSSENKRUPP ELEVATORS FOR ELEVATOR PREVENTATIVE MAINTENANCE AND
REPAIRS FOR A TWO-YEAR TERM AND A TOTAL AMOUNT NOT TO EXCEED \$37,324
(YEAR 1-\$17,298, YEAR 2-\$20,026)**

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Thyssenkrupp Elevators, 3600 Lacey Dr., Suite 100, Downers Grove, Illinois 60126, for Elevator Preventative Maintenance and Repairs; and

WHEREAS, the City prepared a Bid package (Bid Number 20-53) that included Elevator Preventative Maintenance and Repairs; and

WHEREAS, funding for elevator preventive maintenance is budgeted in multiple accounts (General, Parking, and Library Funds) in the 2020 budget for a total amount of \$14,760. Funds are available in each Fund to cover the additional cost of maintenance for the remainder of the year. The 2021 budget will be adjusted to reflect the new contract amount; and

WHEREAS, the City solicited bids in a public bidding process for a two (2) year contract and Thyssenkrupp Elevators, was determined to be the lowest, responsive, responsible bidder with a bid amount of \$37,324 (\$17,298 for year 1 and \$20,026 for year 2), with an option to extend the agreement for one (1) additional (1) year term, upon the same pricing, terms and conditions; and

WHEREAS, both parties agree to the terms and conditions set forth in the Bid, the agreement contained in the City's Bid package for Elevator Preventative Maintenance and Repairs.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:


The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 136 with Thyssenkrupp Elevators, 3600 N. Lacey Dr., Suite 100, Downers Grove, IL 0126, for Elevator Preventative Maintenance and Repairs for a two (2) year term, for a total amount not to exceed \$37,324, with the option to extend the agreement for one (1) additional one (1) year term for the same pricing, terms, and conditions; and that a copy of that certain City of Wheaton Agreement No. 136 is on file with the City Clerk's office as Group Exhibit A to this Resolution R-2020-58 and is hereby incorporated into this Resolution as if fully set forth herein.
