

**RESOLUTION R-2020-91**

**A RESOLUTION AUTHORIZING THE PURCHASE OF A SKID STEER LOADER THROUGH THE OMNIA PARTNERS JOINT PURCHASING PROGRAM WITH ALTORFER CATERPILLAR FOR A TOTAL AMOUNT NOT TO EXCEED \$51,750**

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, the Omnia Partners Cooperative has publicly and competitively bid for heavy equipment sales; and

**WHEREAS**, Omnia Partners has awarded agreement #161534 to Altorfer Caterpillar located in Elmhurst, Illinois, for heavy equipment sales and has made the agreement available to other public entities; and

**WHEREAS**, the City budgeted funds in the CY2020 Fleet Services Fund for a total amount of \$41,416 and reserves are available to accommodate the additional cost; and

**WHEREAS**, the corporate authorities of the City of Wheaton find it reasonable and appropriate to purchase a Skid Steer Loader for the Street Division of the Public Works Department, for a total amount not to exceed \$51,750 through the Omnia Partners agreement #161534 with Altorfer Caterpillar.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, Illinois, that:

The City's Purchase Order #2021110 for the purchase of a 2021 Skid Steer Loader for the Street Division of the Public Works Department through the Omnia Partners agreement #161534 with Altorfer Caterpillar located in Elmhurst, Illinois, for a total amount not to exceed \$51,750, is hereby authorized (the "Purchase") and City staff is directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction. A copy of the City's Purchase Order #2021110 is on file with the City Clerk's office as Exhibit A to this Resolution R-2020-91 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and a copy of the Omnia Partners cooperative agreement #161534 is on file with the City Clerk's office as Exhibit A to Purchase Order #2021110, and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein.
