

**RESOLUTION R-2021-22**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 191 WITH GLOBE CONSTRUCTION, INC. FOR CONCRETE FLATWORK FOR THE ANNUAL SIDEWALK REPLACEMENT PROGRAM AND MISCELLANEOUS CONCRETE WORK FOR A TOTAL AMOUNT NOT TO EXCEED \$180,000**

**WHEREAS**, the City prepared a bid package (Bid Number 21-14) that included concrete flatwork for the City's Annual Sidewalk Replacement Program and other miscellaneous concrete flatwork, such as curb and gutter replacements; and

**WHEREAS**, the City budgeted funds in the Capital Projects Fund in the amount of \$150,000.00 and \$30,000.00 in the General Fund for Concrete Flatwork and Miscellaneous Concrete Work; and

**WHEREAS**, the City solicited bids in a public bidding process and bids were publicly opened and read on March 24, 2021, at 11:00AM and Globe Construction, Inc., was determined to be the lowest, responsive, responsible bidder, with a unit price bid of \$58.00/SY for removal and replacement of 6" driveway pavement, \$6.33/SY for removal and replacement of 4" sidewalk, \$6.43/SY for removal and replacement of 5-6" sidewalk, \$23.95/FOOT for 18 inch wide concrete curb & gutter removal, \$25.00/FOOT for 2 foot wide concrete curb & gutter removal, \$0.50/FOOT for reinforcement bars, and \$14.00/SF for detectable warnings; and


**WHEREAS**, it is necessary for the City to enter into an agreement with Globe Construction, Inc., for concrete flatwork for the Annual Sidewalk Replacement Program and Miscellaneous Concrete Work; and

**WHEREAS**, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for the concrete flatwork for the Annual Sidewalk Replacement Program and Miscellaneous Concrete Work; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Globe Construction, Inc., 1781 West Armitage Court, Addison, Illinois 60101, for Concrete Flatwork for the Annual Sidewalk Replacement Program and Miscellaneous Concrete Work; and

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois that the Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 191, with Globe Construction, Inc., 1781 West Armitage Court, Addison, Illinois, 60101 for Concrete Flatwork and Miscellaneous Concrete Work for a total amount not to exceed of \$180,000.00; and that a copy of that certain City of Wheaton Agreement No. 191 is on file with the City Clerk's office as Exhibit A to this Resolution R-2021-22 and is hereby incorporated into this Resolution as if fully set forth herein.
