

RESOLUTION R-2021-50

A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 192 WITH HDR ENGINEERING, INC. FOR WHEATON AVENUE PEDESTRIAN UNDERPASS REHABILITATION CONSTRUCTION ENGINEERING SERVICES AND OPTIONAL GRANT ADMINISTRATION SERVICES FOR A TOTAL AMOUNT NOT TO EXCEED \$34,898.44

WHEREAS, the City prepared a Request for Proposal package (RFP Number 21-45) that included Wheaton Avenue Pedestrian Underpass Rehabilitation Construction Engineering Services and Optional Grant Administration Services; and

WHEREAS, HDR Engineering Group, Inc. submitted a proposal to provide construction engineering services in the amount of \$34,316.48 and optional grant administration services in the amount of \$581.96 for the Wheaton Avenue Pedestrian Underpass Rehabilitation Construction for a total amount not to exceed \$34,898.44; and

WHEREAS, the City has a satisfactory pre-existing relationship with HDR Engineering Group, Inc. and its proposal meets the City's needs; and

WHEREAS, the City budgeted funds in the Capital Projects Fund in the amount of \$500,000.00. The construction portion of the project was bid and came in at \$275,337.07. Construction engineering services and optional grant administration services is proposed at \$34,898.44 making the total project cost \$310,235.51, which is well under budget; and

WHEREAS, both parties agree to the terms and conditions set forth in the RFP and the agreement contained in the City's RFP package for Wheaton Avenue Pedestrian Underpass Rehabilitation Construction Engineering Services and Optional Grant Administration Services; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with HDR Engineering Group, Inc., 9450 West Bryn Mawr Avenue, Suite 400, Rosemont, Illinois, 60018, for Wheaton Avenue Pedestrian Underpass Rehabilitation Construction Engineering Services and Optional Grant Administration Services.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 192, with HDR Engineering Group, Inc., 9450 West Bryn Mawr Avenue, Suite 400, Rosemont, Illinois, 60018, for Wheaton Avenue


