

**RESOLUTION R-2021-61**

**A RESOLUTION AUTHORIZING THE PURCHASE OF TWO (2) REPLACEMENT AMBULANCES FROM DEMERS AMBULANCE USA, INC. THROUGH ITS AUTHORIZED DEALER, NORTH CENTRAL EMERGENCY VEHICLES, INC. IN ACCORDANCE WITH THE HOUSTON- GALVESTON AREA COUNCIL COOPERATIVE PURCHASING PROGRAM'S CONTRACT #AM10-20 FOR A TOTAL AMOUNT NOT TO EXCEED \$446,776.80**

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, the Houston-Galveston Area Council ("H-GAC") is council of governments comprised of a region wide voluntary association of local governments in the State of Texas operating under Chapter 391 of the Texas Local Government Code and is authorized to contract with eligible entities to perform governmental functions including the purchase of goods and services; and

**WHEREAS**, the H-GAC is a political subdivision of the State of Texas; and

**WHEREAS**, the H-GAC Cooperative Purchasing Program (HGACBuy) establishes contracts for a variety of products and services through public and competitive solicitations, and permits member governments to purchase products and services through those contracts; and

**WHEREAS**, the City is a member of H-GACBuy; and

**WHEREAS**, the H-GACBuy Contract #AM10-20 has been publicly and competitively bid for ambulances, emergency medical services ("EMS") rescue vehicles, and other special service vehicles; and

**WHEREAS**, the H-GAC has identified Demers Ambulance USA, Inc., as a low responsible bidder for HGAC contract #AM10-20 for ambulances that meet the City's specifications; and

**WHEREAS**, the City budgeted funds in the Vehicles account in the Fleet Services Fund for an amount of \$453,200.00; and

**WHEREAS**, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure two (2) replacement ambulances for the Fire Department from Demers Ambulance USA, Inc., through its authorized dealer, North Central Emergency Vehicles, Inc., 12249 S. Rhea Drive, Suite #4, Plainfield, Illinois 60585 in accordance with H-GAC Contract #AM10-20, for a total amount not to exceed \$446,776.80.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, Illinois, that:

Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.


Section 2. The City's Purchase Order #2022064 for two (2) replacement ambulances for the Fire Department from Demers Ambulance USA, Inc., through its authorized dealer, North Central Emergency Vehicles, Inc., located at 12249 S. Rhea Drive, Suite #4, Plainfield, Illinois 60585, in

accordance with the H-GAC cooperative contract #AM10-20, for a total amount not to exceed \$446,776.80, is hereby authorized (the "Purchase").

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
