

**RESOLUTION R-2021-94**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 233 WITH  
DESMAN, INC. FOR PROFESSIONAL ENGINEERING SERVICES FOR THE WHEATON PLACE AND  
WILLOW AVENUE PARKING STRUCTURES FOR A TOTAL AMOUNT NOT TO EXCEED \$21,290**

**WHEREAS**, the City prepared a Request for Proposal package (RFP Number 21-105) that included Engineering Services for Wheaton Place and Willow Avenue Parking Structures; and

**WHEREAS**, Desman, Inc. submitted a proposal to provide professional engineering services for the Wheaton Place and Willow Avenue parking structures in the amount of \$21,290; and

**WHEREAS**, it was determined by the City that the DESMAN, Inc. proposal meets the City's needs; and

**WHEREAS**, the City budgeted \$15,000 in the Parking Fund for Engineering Services for Wheaton Place and Willow Avenue Parking Structures. A total of \$20,000 was allocated in the Parking Fund for sealant replacement, however this work will not be completed. There are sufficient funds available in the Parking Fund to accommodate the additional cost; and

**WHEREAS**, both parties agree to the terms and conditions set forth in the RFP and the agreement contained in the City's RFP package for Engineering Services for Wheaton Place and Willow Avenue Parking Structures; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with DESMAN, Inc., 20 North Clark Street, 4<sup>th</sup> floor, Chicago, Illinois, 60602, for Engineering Services for Wheaton Place and Willow Avenue Parking Structures.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 233, with DESMAN, Inc., 20 North Clark Street, 4<sup>th</sup> floor, Chicago, Illinois, 60602 for Engineering Services for the Wheaton Place and Willow Avenue Parking Structures for a total amount not to exceed \$21,290; a copy of that certain City of Wheaton Agreement No. 233 is on file with the City Clerk's office as Exhibit A to this Resolution R-2021-94 and is hereby incorporated into this Resolution as if fully set forth herein.
