A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 246 WITH ILLINOIS COMMUNICATIONS SALES, INC. FOR VEHICLE UPFITTING AND COMMUNICATION EQUIPMENT SERVICES FOR A TOTAL AMOUNT NOT TO EXCEED \$54,800

WHEREAS, the City prepared a bid package (Bid Number 21-114) that included Vehicle Upfitting and Communication Equipment Services; and

WHEREAS, City staff annually requests funding in multiple accounts from multiple departments for equipment repair and maintenance services. Installation services are typically funded as part of vehicle replacements in account 60070647-70050; and

WHEREAS, the City solicited bids in a public bidding process for a three (3) year agreement and bids were publicly opened and read on October 26, 2021, at 11:00 AM. Illinois Communications Sales, Inc. was determined to be the lowest, responsive, responsible bidder with a bid amount of \$54,800, with an option to extend the agreement for two (2) additional one (1) year terms, upon the same pricing, terms, and conditions; and

WHEREAS, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for Vehicle Upfitting and Communication Equipment Services; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Illinois Communications Sales, Inc., 145 Covington, Bloomingdale, Illinois 60108, for Vehicle Upfitting and Communication Equipment Services.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 246 with Illinois Communications Sales, Inc., 145 Covington, Bloomingdale, Illinois 60108, for Vehicle Upfitting and Communication Equipment Services for a three (3) year term, for a total amount not to exceed \$54,800 (\$18,266.66 annually), with the option to extend the agreement at the same prices and terms for two (2) additional one (1) year terms; and that a copy of that certain City of Wheaton Agreement No. 246 is on file with the City Clerk's office as Exhibit A to this Resolution R-2021-102 and is hereby incorporated into this Resolution as if fully set forth herein.
