

**RESOLUTION R-2022-13**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 273 WITH AVI SYSTEMS, INC. FOR AN AUDIO-VISUAL EQUIPMENT AND INSTALLATION UPGRADE AT CITY HALL FOR A TOTAL AMOUNT NOT TO EXCEED \$461,236**

**WHEREAS**, the City solicited bid package (Bid Number 21-112) that included an Audio-Visual Equipment and Installation Upgrade at City Hall; and

**WHEREAS**, the City solicited bids in a public bidding process and bids were publicly opened and read on October 6, 2021, at 11:00 AM. AVI Systems, Inc. was determined to be the lowest, responsive, responsible bidder with a bid amount of \$435,436, including support services for year 1; and

**WHEREAS**, the City has determined that additional support services are needed for year 2 and year 3 for an additional amount of \$25,800 (Year 2-\$12,900, Year 3-\$12,900) and for a total amount not to exceed \$461,236.

**WHEREAS**, the City budgeted \$122,424 in the Building Renewal Fund and \$102,663 in the Capital Equipment Replacement Fund in the CY2022 budget for a total amount of \$225,087 for an Audio-Visual Equipment and Installation Upgrade at City Hall and reserves are available in the Capital Equipment Replacement Fund to accommodate the additional cost; and

**WHEREAS**, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for an Audio-Visual Equipment and Installation Upgrade at City Hall; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with AVI Systems, Inc. located at 703 W. Algonquin Road, Arlington Heights, Illinois 60005, for an Audio-Visual Equipment and Installation Upgrade at City Hall.


**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 273 with AVI Systems, Inc. located at 703 W. Algonquin Road, Arlington Heights, Illinois 60005, for an Audio-Visual Equipment and Installation Upgrade at City Hall; and that a copy of that certain City of Wheaton Agreement No. 273 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-13 and is hereby incorporated into this Resolution as if fully set forth herein.
