

**RESOLUTION R-2022-18**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 280 WITH THOMAS ENGINEERING GROUP FOR PROFESSIONAL ENGINEERING SERVICES FOR A WATER MAIN REPLACEMENT FOR A TOTAL AMOUNT NOT TO EXCEED \$40,709.67**

**WHEREAS**, the City solicited a Request for Proposals (RFP Number 22-37) for Professional Engineering Services for a Water Main Replacement; and

**WHEREAS**, staff received and reviewed two proposals for Professional Engineering Services for a Water Main Replacement; and

**WHEREAS**, staff determined that each firm was fully qualified to perform the scope of services therefore cost was the deciding factor; and

**WHEREAS**, Thomas Engineering Group was determined to be the lowest responsive and responsible Proposer with an amount of \$40,709.67 for Professional Engineering Services for a Water Main Replacement; and

**WHEREAS**, the City budgeted funds in the CY2022 Water Capital Projects Fund in an amount of \$80,000 for Professional Engineering Services for a Water Main Replacement; and


**WHEREAS**, both parties agree to the terms and conditions set forth in the RFP and the agreement contained in the City's RFP package for Professional Engineering Services for a Water Main Replacement; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Thomas Engineering Group, 2625 Butterfield Road, Suite 209W, Oak Brook, Illinois, 60523 for Professional Engineering Services for a Water Main Replacement.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 280, with Thomas Engineering Group, 2625 Butterfield Road, Suite 209W, Oak Brook, Illinois, 60523 for Professional Engineering Services for a Water Main Replacement for a total amount not to exceed \$40,709.67; and that a copy of that certain City of Wheaton Agreement No. 280 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-18 and is hereby incorporated into this Resolution as if fully set forth herein.
