
**A RESOLUTION APPROVING THE METRA COLLEGE AVENUE STATION



Legal Description

LOT 4 AND 5, THE WEST HALF OF LOT 15, AND ALL OF LOTS 16, 17 AND 18 IN ANDERSON'S RESUBDIVISION OF A PART OF BLOCK 5 OF ANDERSON'S ADDITION TO WHEATON IN THE WEST HALF OF THE NORTHWEST QUARTER OF SECTION 15, TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT OF SAID ANERSON'S RESUBDIVISON RECORDED AUGUST 12, 1885, AS DOCUMENT 34825, IN DUPAGE COUNTY, ILLINOIS.

LOTS 19 THROUGH 30 BOTH INCLUSIVE, EXCEPT THE NORTHERLY 14 FEET (MEASURED AT RIGHT ANGLES THERETO), LOTS 31 THROUGH 49, BOTH INCLUSIVE, ALL THAT PART OF VACATED DEPOT PLACE LYING SOUTHERLY OF LOTS 19 THROUGH 34, NORTHERLY OF LOTS 38 THROUGH 49, EASTERLY OF THE WESTERLY LINE OF LOT 19 EXTENDED SOUTHERLY TO THE NORTHWEST CORNER OF LOT 49 AND LYING NORTHERLY OF THE NORTHERLY RIGHT OF WAY LINE OF THE CHICAGO NORTHWESTERN RAILROAD (UNION PACIFIC RAILROAD) ALL IN BLOCK 5 IN ANDERSON'S ADDITION TO WHEATON, BEING A SUBDIVISION OF PART OF THE WEST HALF OF THE NORTHWEST QUARTER OF SECTION 15, TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED JUNE 25, 1885 AS DOCUMENT 24684, IN DUPAGE COUNTY, ILLINOIS.
