

RESOLUTION R-86-05  
A RESOLUTION AUTHORIZING THE DISPOSAL  
OF CERTAIN SURPLUS PROPERTY

WHEREAS, Section 2-506 of the Wheaton City Code sets forth a procedure for disposal of property found to be surplus; and

WHEREAS, a request to dispose of property described in Exhibit "A" attached hereto and made a part hereof by reference, has been submitted; and

WHEREAS, the City Manager has approved said request and forwarded it to the City Council for authorization.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that the City Manager is authorized to proceed with disposal of said surplus property in compliance with the provisions of Section 2-506, and is authorized to either advertise for bids, contact directly likely purchasers, and to take other such responsible means to cause the most profitable recovery to the City of Wheaton, or, if unable to sell said property, give said property to any not-for-profit corporation, organization, or entity having its principal place of business or doing a substantial amount of business in the city, at no charge to the recipient or to junk the property at the least possible cost to the city. The City Manager shall report back to the City Council in compliance with paragraph (i) of said Section when all or a majority of said property has been disposed of.

The below identified vehicle has been awarded to the City of Wheaton Police Department by court order pursuant to article 36 proceedings initiated from a felony arrest made by Investigator Uhlir for *indecent solicitation of a minor*.

The vehicle will be titled to the City of Wheaton. Investigative Division Commander Eversole requests that this vehicle be placed into fleet service to replace unit #300. That vehicle will then be disposed of thru the State of Illinois, as it was seized as part of a drug asset forfeiture proceeding. Once disposed of, the Wheaton Police Department will be awarded 65% of the proceeds from the sale of the vehicle.

Once approved I will work with Commander Eversole to coordinate the replacement.
