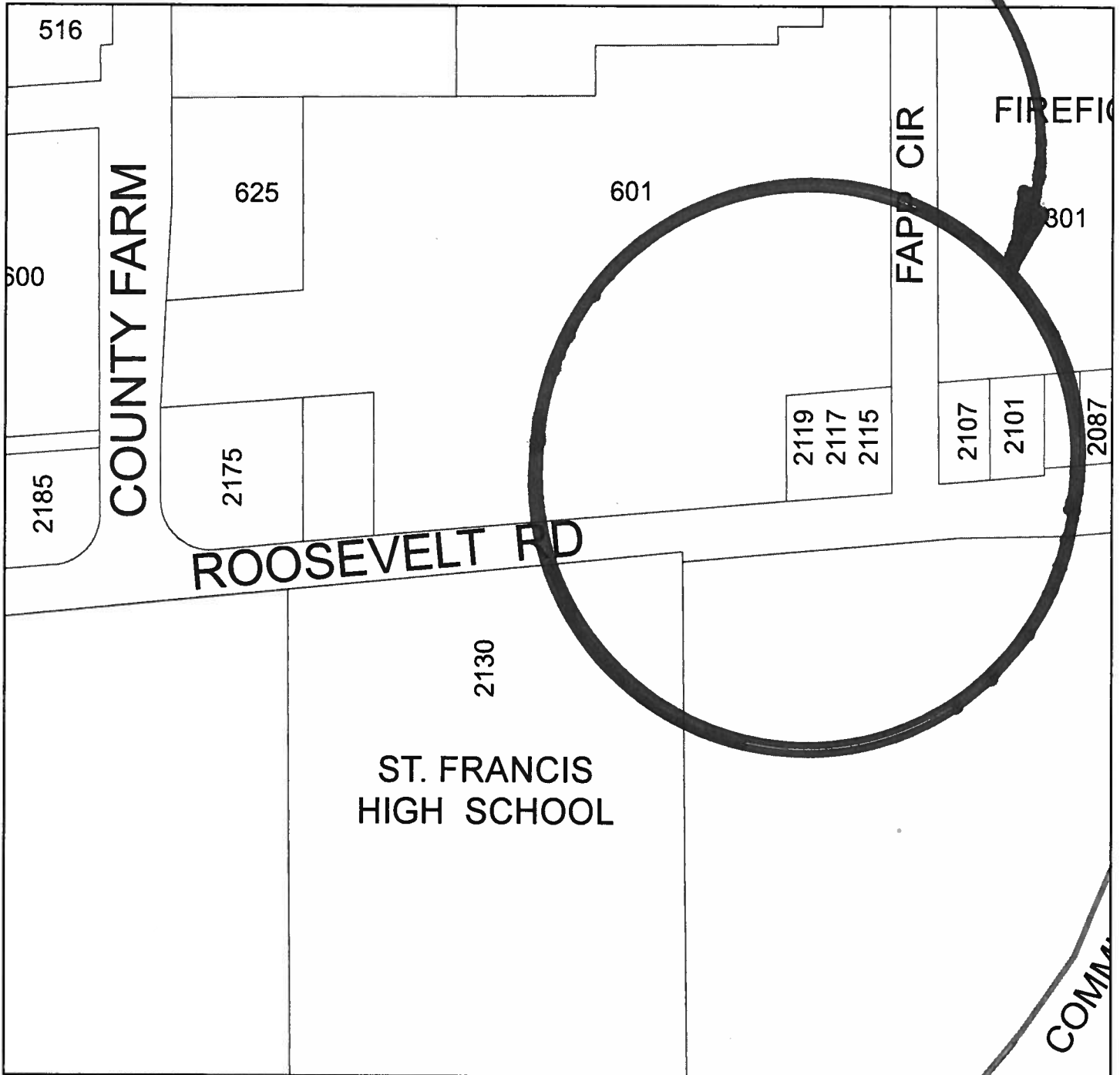
Re: *2115-2117-2119 W Roosevelt Road*

Attached is a revised copy of the City of Wheaton official address map that amends the map as follows:

- 1 Additional unit added between 2115 and 2119 W Roosevelt Road
New unit is 2117 W Roosevelt Road.
- 2 207, 209 and 227 W. Willow Avenue parking lots.
- 3 Cloutier Daniels Subdivision. Two lots on Manchester Road.
- 4 Our records indicate that Campbell has always had an "Avenue," designation and NOT street. Please adjust your records to remove any references to "Campbell Street and replace them with **Campbell Avenue.**" This is causing a problem with billing, mail delivery and other services. We note that the current DuPage County plat book and County Clerk's database also incorrectly labels this as street and should be changed to Avenue.

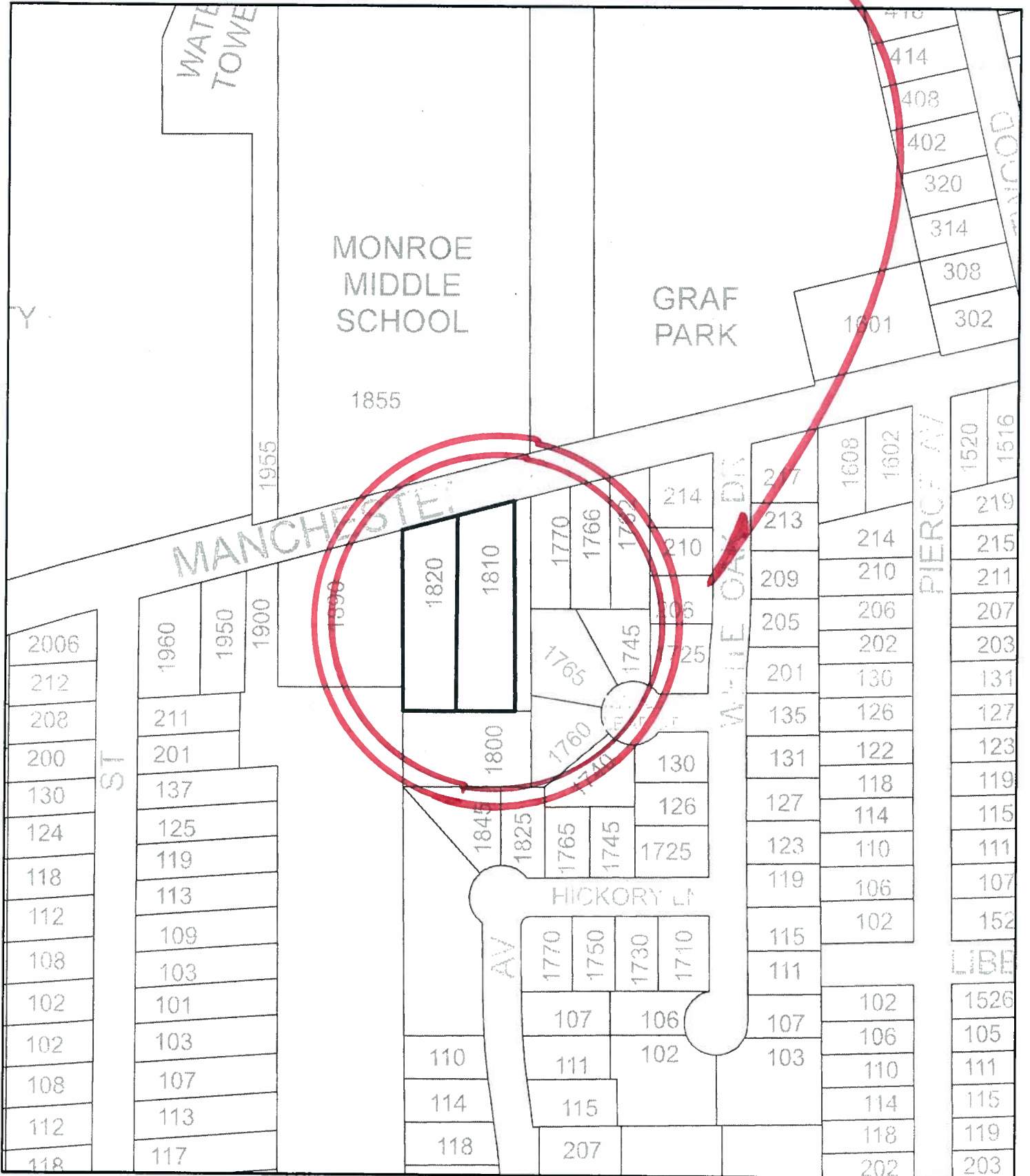

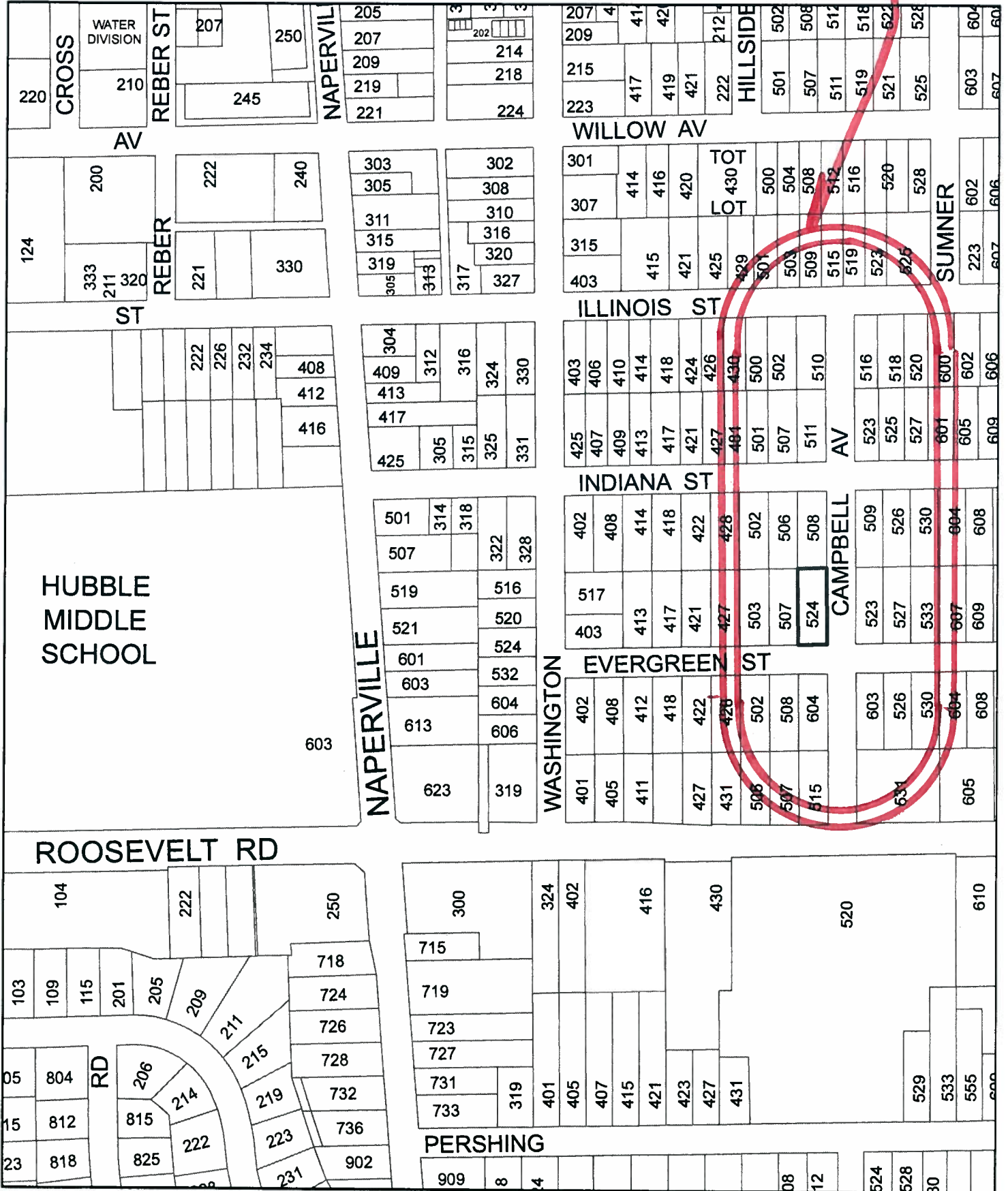

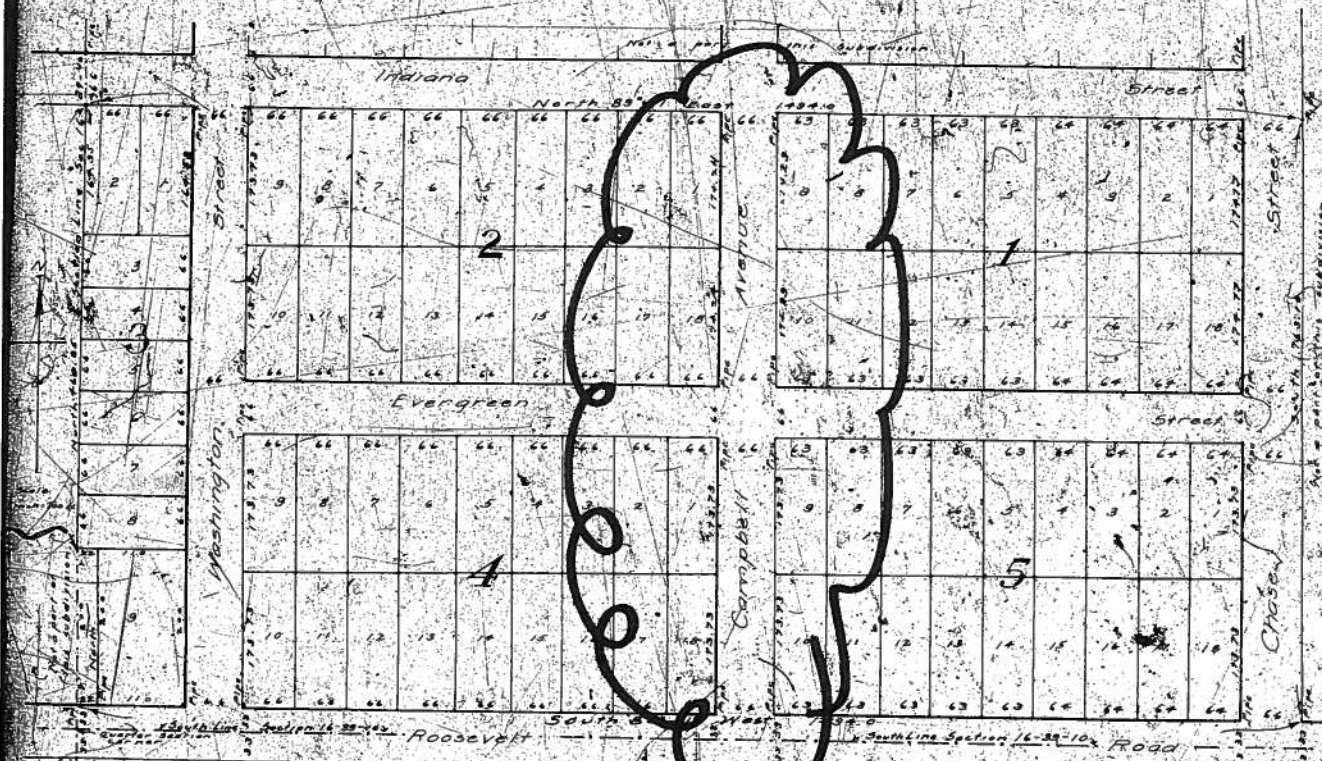
