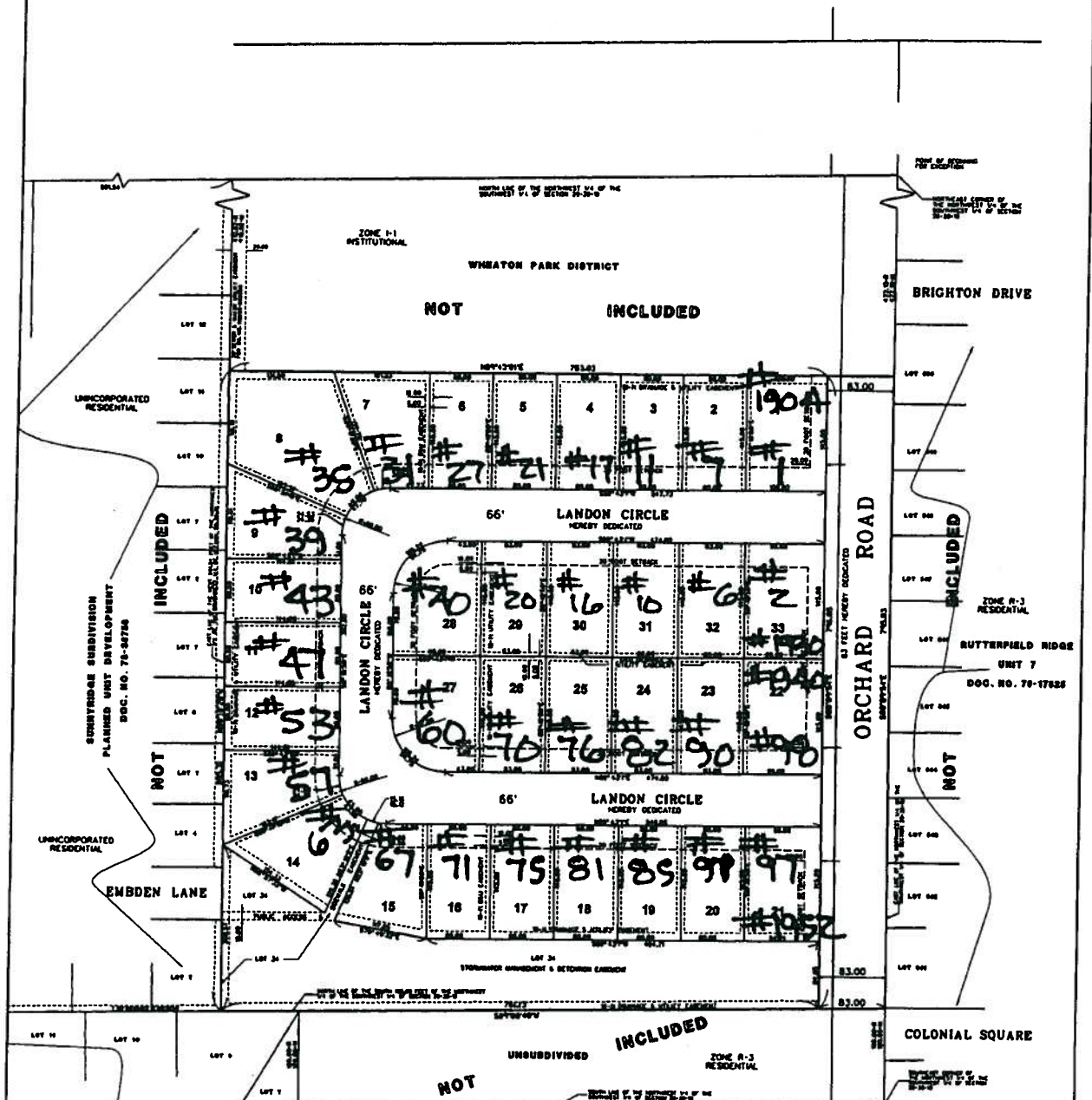

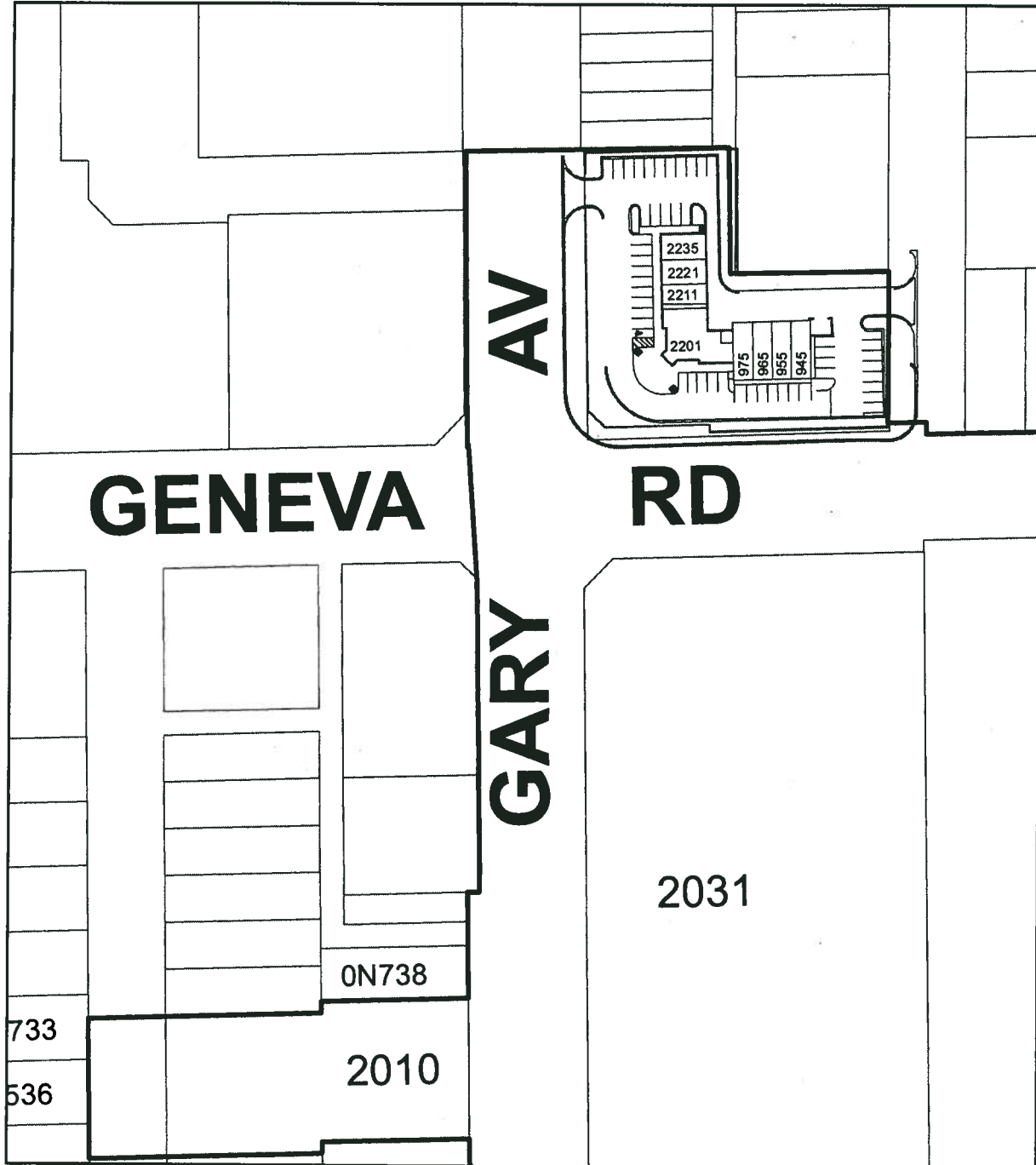

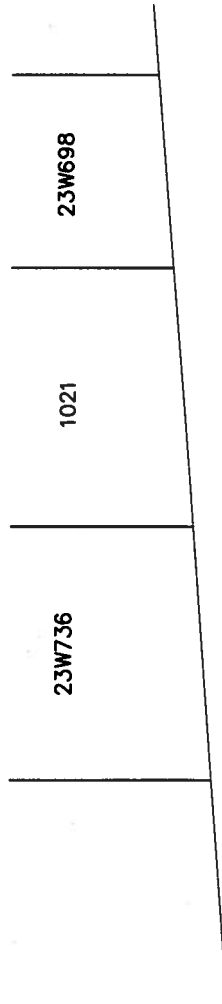
Geneva Lakes Gary Ave & Geneva Road



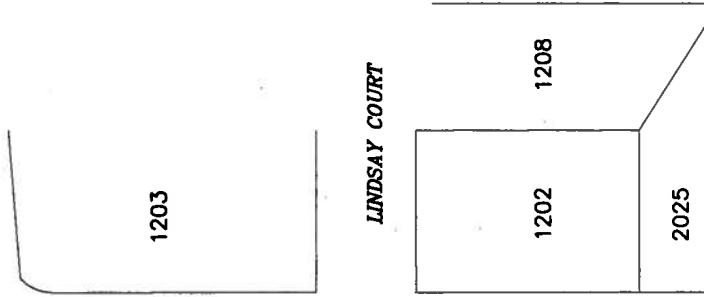
ADDRESS MAP OF
